# West Covina Sued To Implement Districting

**WEST COVINA** - The City of West Covina is being sued by three of its citizens and 5 attorney groups that are representing the trio who are, Armando Sanchez, Community Activist Alfred Williams and Juan Reinoso who has been hard on West Covina when the city did not retain the company he was connected with as he is the president of Urban Graffiti Enterprise. He did not get the city contract and was angered and has since continued to complain about graffiti in West Covina often verbally attacking the city councilmembers at council meetings.

The issue is "Districting" in the city for its council representation. This issue was brought up a few years ago and voted on, and the "people" of West Covina VOTED NO on Districting 2 to 1. Presently the city has at-large elections. Everyone can vote for the candidates of their choice.

The California Voting Rights Act of 2001 expanded on the federal Voting Rights Act of 1965, making it easier for minority groups in California to prove that their votes are being diluted in "at-large" elections. In 1986, the U.S. Supreme Court established conditions that must be met to prove that minorities are being disenfranchised which could allow for a lawsuit.

The lawsuit states that racially

polarized voting exists in West Covina.

Over 30 people addressed the issue at the latest council meeting. More the 20 people support fighting the lawsuit while nine supported districting. Three people addressed the issue and basically wished the council well in the decision making.

Council and staff has made it clear that it could cost millions to fight this lawsuit and it would cost the city either way, win or lose.

These lawyers have conspired together to sue cities with the same type of lawsuits knowing

that they will get paid big bucks no matter what.

One of the speakers was Bill "Wild Bill" Elliott who tossed his opinion without pulling any punches. He laid it on the line naming the three plaintiffs and his strong disapproval of this action and letting people know that this in itself is racist. He stated

that you could feel the racism from all three when you simply walk by them. Other speakers stated that this was criminal and reminding the council and staff that the "majority" of the city, well over 50 percent are Hispanic. The speakers called this a "shakedown", a criminal conspiracy, extortion, blackmail,

among other things.

When the elected official, the City Clerk of West Covina, Nick Lewis, who is also an attorney, stated his strong disapproval and congratulated the trio, "Alfred Williams, Juan Reinoso and Armando Sanchez, for basically screwing the city and its citizens. He talked about the law and how it applies citing that one of the attorneys suing the City of West Covina and other cities, Robert Rubin, actually put the language together for the California Voting Rights Act. This appears to fit right in to allow him to sue cities.

Lewis went on and narrated the law and how it applies. The cities that are sued have to pay no matter if they win or lose. They cannot recover any costs if they win and still have to pay the suing attorneys and plaintiffs. "We are screwed!" stated Lewis as he turned to the audience and back to the council holding his hands up. Lewis closed with his final statement being, "I hope when they die, I am around to see it at the time." This led to applause from the audience as he left the lectern.

## Baldwin Park Unified Superintendent Shares Vision with Business Leaders

**BALDWIN PARK** - Baldwin Park Unified Superintendent Froilan N. Mendoza on Oct. 13 shared the District's vision for student achievement, goals for securing its vision and recent program expansions with members of the Baldwin Park Business Association.

The breakfast gathering, held at the Baldwin Park Unified District Office, drew representatives of Kaiser Permanente Baldwin Park Medical Center, SCE First Federal Credit Union, Wells Fargo, the Boys & Girls Club, the City of Baldwin Park, Baldwin Park Historical Society and the American Cancer Society.

Mendoza stressed the importance of partnerships as a key element of the District's focus on helping students achieve their greatest potential, an effort that requires a combination of academic and social/emotional support.

"We want to ensure everyone is college and career ready," said Mendoza, a 16-year Baldwin Park Unified educator who assumed the role of superintendent in fall 2015. "It's about the whole child, not just the academic piece."

Baldwin Park Unified's trio of goals advocate for providing rigorous academics, creating an environment of support, under-

standing and emotional safety, as well as promoting a culture of collaboration by strengthening communication and partnerships.

For the first goal, the District is converting its libraries from repositories of books into dynamic research and collaboration centers for students and expanding its focus on science, technology, engineering and math (STEM) instruction. That includes an effort to create prototypes for multi-lingual learning environments.

"It's pretty exciting," Mendoza said. "We're looking at integrating technology and our Dual Language program. There's a lot of research that shows that in our global society this is one way to help students meet the needs of the future."

For the second, the District is implementing Positive Behavioral Supports and Interventions, a discipline system that seeks to reinforce positive behaviors, and expanding health staffing at all campuses.

For the third, District leaders are focusing on a shared mission to "ensure high achievement for all learners" and boosting teacher collaboration through professional learning communities.

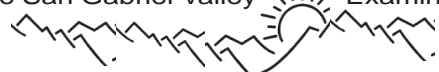
"True collaboration is looking at the data and coming up with the

solutions that will work for our kids. We're investing in a process that will ensure our students succeed," Mendoza said. "This effort is already coming up with a lot of good ideas for what we can do for our students."

The District is also strengthening college and career pathways, an effort that includes partnerships with the business community. Mendoza thanked the business leaders for partnering in the effort to help students grow, and said those partnerships should benefit both parties.

Mendoza shared the District's most recent accolades: 16 of 20 campuses designated as California Gold Ribbon schools in the last two years, North Park Continuation High School honored as a Model Continuation School, and the District's Dual Language program recognized as one of two California recipients of the Multiple Pathways to Bilingual Award.

Mendoza also introduced members of his cabinet: Deputy Superintendent of Business Services and Operations Lydia Cano, Assistant Superintendent of Student Achievement Dr. Randy E. Gray and Assistant Superintendent of Student Achievement Angela Salazar.



## County Parks To Receive Improvements

**LOS ANGELES COUNTY** – The Board of Supervisors today approved grants totaling more than \$5 million that will improve park facilities in several communities in the Fifth Supervisorial District announced Supervisor Michael D. Antonovich.

• Charles S. Farnsworth Park in Altadena will receive \$2 million towards improvements to the community building and baseball field, as well as the renovation of a shade structure and horseshoe area.

tion of a shade structure and horseshoe area.

• The Los Angeles County Arboretum and Botanic Garden in Arcadia will receive \$1.7 million to repair existing adobe walls, roof structure and modification of pathways, paving, directional signs and other site amenities at the historic Reid-Baldwin Adobe.

• Crescenta Valley Community Regional Park in La Crescenta will receive \$500,000 to rehabilitate restrooms and other related park amenities at.

• La Verne Wilderness Area in La Verne will receive \$500,000 towards construction of a loop trail and debris barriers, as well as native plant landscaping.

• McCambridge Park in Burbank will receive \$200,000 to rehabilitate the existing War Memorial.

• Vincent Lugo Park in San Gabriel will receive \$110,000 to develop a play area and install fitness equipment.

"Working with our cities and communities, these vital park improvement projects will have a positive impact on the quality of life for our county residents," said Supervisor Antonovich.

Originating from the Los Angeles County Safe Neighborhood Parks Proposition of 1996, the grant funding for these projects was allocated from available Specified Excess Funds.

## Kiddie Train Ride Accident Injures 9

**COVINA** - On October 22, 2016 at approximately 2:08 PM, the Covina Police Department received a radio call of a traffic collision involving a small scale amusement train ride that overturned in the area of the 2100 block of E. Rancho Culebra in the City of Covina. Upon arriving to the location, officers determined that the driver of the ride lost control as it was traveling down a hill and the occupants of the train were ejected onto the roadway. The occupants of the train ride suffered minor injuries, most of which included contusions and abrasions.

The victims were treated at the scene by the Los Angeles County Fire Department and nine of

the occupants were transported to local area hospitals for treatment. Seven of the injured were juveniles ranging between the age of 3 and 7 and two were adults. The current medical status of the victims is unknown at this time.

The investigation into the cause of the accident is being conducted by the Covina Police Department Traffic Division and no arrests have been made.

## Nearly \$2 Million Allocated For New Senior And Community Center In Covina

**LOS ANGELES COUNTY** – Supervisor Michael D. Antonovich announced that the Board of Supervisors has approved a \$1.9 million grant towards the construction of a new 16,000-square-foot Senior and Community Center in the city of Covina.

"Once completed, this new Senior and Community Center will help the city and county provide convenient easy accessibility to the programs and services

seniors need to ensure a healthy and active lifestyle," said Supervisor Antonovich.

The grant funding, approved from Cities Excess Funds available to the Fifth Supervisorial District, will help finance the \$6.5 million project. The City of Covina will supplement \$4 million from its General Fund, and an additional \$600,000 in Community Development Block Grant funds will be provided.

## Baldwin Park Unified Launches Open Enrollment for District Schools

**BALDWIN PARK** – Parents of students who reside within the Baldwin Park Unified School District boundaries may enroll their children in any District elementary school during the annual open enrollment period, which runs from Tuesday, Nov. 1 through Monday, Dec. 5.

The District offers a transitional kindergarten program to children whose fifth birthday lies between Sept. 1 and Dec. 2.

The selection process shall be conducted immediately after the

application period, and enrollment in a school of choice shall be determined by lottery (NOT on a first-come first-served basis).

A waiting list shall be established to indicate the order in which applicants may be accepted as more openings occur. Late applicants shall be added to the waiting list by subsequent lotteries.

Parents can pick up an open enrollment application at their child's current school beginning

Tuesday, Nov. 1.

Applicants will be notified by the schools as to whether their applications were approved, denied, or placed on a waiting list.

Once a student is promoted from an elementary school or from eighth to ninth grade, the student is assigned to the original school of residence. Transportation is the responsibility of the student's family. California Inter-scholastic Federation (CIF) Eligibility Rules apply to ninth-through 12th-grade students.

## County To Employ Detection Canines To Serve With D.I.S.A.R.M. Teams

**LOS ANGELES COUNTY** – A motion by Supervisor Michael D. Antonovich, calling for a report on expanding the use of detection canines to the Probation Department's D.I.S.A.R.M. program was unanimously approved by the Board of Supervisors.

Initiated by Antonovich in February 2000, the D.I.S.A.R.M. (Developing Increased Safety through Arms Reduction Man-

agement) program has conducted over a quarter million searches seizing nearly 11,000 weapons and drugs valued at approximately \$730 million from high-risk probationers.

"The use of these specially-trained dogs for detection of weapons and narcotics can improve safety concerns and allow residents to resume their normal daily activities sooner and with

less disruption," Antonovich said. "Having personally participated in D.I.S.A.R.M. search operations, I have witnessed the challenges faced by these probation officers and the vital need for canine assistance."

The report is due in 2 weeks and will include additional information at the request of Supervisors Solis and Kuehl.

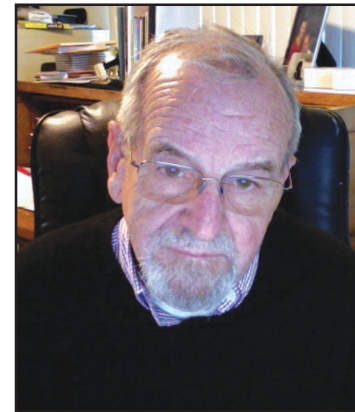
# You Bet! Power Does Corrupt

We want America to remain the strongest nation on earth, but the competition we are now getting from China is not an unmitigated difficulty. Competition just might improve everyone’s conduct, including ours.

Simple justice depends on some division of power among competing forces. Certainly the framers of the Constitution understood that unlimited power always corrupts. Whatever flaws they wrote into that document, not even the most conservative Federalists were about to copy the English system with all the power vested in an unassailable monarch. But even the Brits have traditionally had ways to level out the worst uses of royal authority, beginning with the Magna Car-

ta. So the American Constitutional government relies on competing sources of power. Even our least populous states have the same number of senators as the most populous states. And we are saved from an imperial Presidency by the other two branches of government—the Legislative and the Judicial. Of course this system also has its down side, and when power is evenly divided sometimes very little is accomplished. The last eight years offers a striking illustration of that problem.

But back to the initial point I wanted to make when I started this discourse. On one hand, the total annihilation of Donald Trump and his Republican cohorts is greeted with considerable glee in the political circles in which I usually travel. But not so fast. As our form of government recognizes the importance of the Constitution’s checks and balances, common sense suggests the critical need for at least two political parties, each with some significant access to power. If for the ensuing years the footing that has undergirded the Republican Party is now threatened, I doubt if that is an unqualified blessing for America. Perhaps we need at least one alternative party with an agenda the in-power party cannot simply dismiss. Trump has managed to destroy much of what made the Republican Party valuable. It is going to take time to get it back on its feet. Or we may be in for a wholesale realigning of our current party politics. In the meantime, the Democrats need to take a careful look before they assume that having won such a striking electoral victory they can just ignore what in our system is sometime called ‘the loyal opposition.’

# What Mask Are You Wearing?

Of all the Halloween events I’ve participated in, one stands out from the rest. I was supposed to walk the neighborhood with my family, but my appointments kept me late in Los Angeles. By the time I got home and caught up with my family, they were visiting their last house. I jumped in line still in my office attire, and the host standing at the door in full Halloween costume called to his wife, “Honey come and look - this must be a Republican!”

I wonder if the celebration of Halloween did not develop out of the mirroring of real life. We all wear masks every day - sometimes without even knowing we are wearing them. These are masks that may hide or in some way disguise emotions and feelings like sadness, worry, and pain. Or just for a brief period of time you consciously represent yourself as someone you’ve always wanted to be. I have a son-in-law who uses this occasion to mask as a personality that he finds interesting. And for a short period of time he seems to be that person.

But these masks, whether worn on Halloween or throughout the year, are just disguises, and without our consent they are unable to fasten themselves upon us. These masks have no ability to speak, act, influence, or affect the thinking of the one who recognizes the masks for what they are - a pretense. But could it be that the sadness, worry, pain, etc., are themselves a false representation of who we actually are?

God as described in the Bible as all good, has created each of us to be His likeness, the uniquely varied expression of good. The true identity of man as given by God is revealed once masks are removed. How do we go about removing these masks? I find that a deep, prayerful connection to God is the key. Mary Baker Eddy, biblical researcher, Christian

healer, and writer about man’s true identity with God, wrote in Science and Health with Key to the Scriptures: “All reality is in God and His creation, harmonious and eternal. That which He creates is good, and He makes all that is made. Therefore the only reality of sin, sickness, or death is the awful fact that unrealities seem real to human, erring belief, until God strips off their disguise.”

This is the way to deal with masks that has worked for me: seek to identify myself as an individual expression of God’s goodness, which strips away masks or false identities.

This is what I had to do when I was working to resolve a racial inequality problem in a southern school district program. I knew going into the job that many felt a resolution could not be found, and this problem was creating an increasingly toxic school and work environment. As I prayed to remove these seemingly unyielding masks of anger, intolerance, and inequality, I realized that I must meet with all concerned and see each person’s true, all-good identity. At that point I knew I would be able to find a solution.

After an orderly meeting covered by the local media, where all individuals were able to express their viewpoints, I gave my thoughts, rationale, and decision. The next day the morning newspaper carried this headline: “Ingwerson is a Healer.” Of course, I knew it was this view of man in God’s likeness that was the “Healer,” not me personally. Harmony was established as masks were removed.

What is even more important

to me is that when masks worn by different people are removed and harmony is expressed, God’s true nature, which before was also disguised, is now revealed. Although God’s true nature can never truly be masked, people have the tendency to perceive masks that for a time seem to hide God’s goodness. When doubt and fear cloud my thinking, for example, I again hold to the idea that God is all good, all powerful, and all comforting. Just touching on this idea brings me closer to this boundless divine Love and I’m able to discern and dismiss these masks as a false representation of both God and man.

So this Halloween and throughout the year let’s maintain in our thinking those spiritual qualities described by Jesus when he said, “These things have I spoken unto you, that my joy might remain in you, and that your joy might be full.” And explained by Eddy in Unity of Good, “The evil accompanying physical personality is illusive and mortal; but the good attendant upon spiritual individuality is immortal.” And when you are asked what you are going to be this Halloween, you will know that under that removable fun or scary mask, you are going as your true self.

## Monetary Policy Has Turned Upside Down

Monetary policy turned upside down recently. In effect, the Bank of Japan tightened in pursuit of faster growth, while the Federal Reserve procrastinated despite strong US job market gains. It was confusing - so confusing the Wall Street Journal described the BOJ's policy shift as "opening the monetary spigots" - and may be best understood as indicating both the Fed and BOJ are starting to think the world, and therefore monetary policy, doesn't work the way it used to.

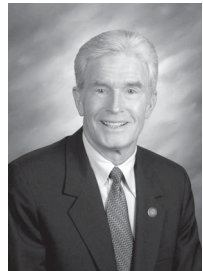
Ben Bernanke introduced forward guidance in 2009 when the Fed was scrounging for tools after dropping the fed funds rate near zero. By pledging to keep fed funds near zero for a "considerable period," the Fed was able to flatten the yield curve well beyond the overnight rate directly controlled by the Fed's open market desk.

Now with the economy at or near full employment, the Fed's forward guidance works in the other direction. Rather than promising a considerable period of near-zero rates, the Fed uses its forecasting to communicate how much tightening is likely and when it will arrive. The forecast not only communicates a median forecast, but also the spread of expectations among the FOMC, effectively communicating the committee's uncertainty.

Legislative response to uncertainty has a lot to do with the plunge in demand for credit in the aftermath of the financial panic of 2007-09 and the sweeping regulatory reform following soon after. Regulation was, after all, designed in part to prevent certain types of credit growth. But you won't hear about that from the Fed. The last thing Yellen wants to do is jeopardize her last traces of support from Congress by questioning Dodd-Frank. Still, regulation has affected borrower behavior enough that it has to have had some effect on the relationship between interest rates and economic growth.

Other than the government, no one borrows at the risk free rate. They borrow at a spread above the risk free rate. In the wake of the

financial crisis and Dodd-Frank reforms, whole classes of mortgage borrowers were cut off. So were many floating rate loan options. Many of the products and services typically funded with floating-rate mortgage debt in the past are now sold using loans funded with fixed payments, including car loans, student loans and credit card loans.

The result has been a higher marginal borrowing cost relative to the natural rate, which means for the two-thirds of the economy accounted for by consumers, rates have to be lower than they used to be to have the same cash flow impact.

### LAND OF THE RISING RATES

As strange as the Fed decision to guide rates lower while talking about the need to raise them, it was stranger still when the Bank of Japan raised rates while underscoring its commitment to boosting inflation.

When the plan to steepen the Japanese yield curve leaked in early August, JGB 10-yr yields were -0.30%. Recently, the BOJ's policy board announced a target of zero, a few basis points higher than they were trading at the time. The goal is to ensure there more likely will be investment opportunities with positive yields at the long end of the yield curve, so that pensions, insurance companies and banks have viable investment opportunities.

### Bottom Line: THERE IS A LIMIT

The global economy, United States included, is stuck in the kind of slow-growth, low-inflation grind we all thought was a Japanese anomaly ten years ago. The good news: as bad as 1.2% GDP growth, 1.5% inflation and near record-low interest rates

are, things could be worse. In America we have credit growth and it has slowly accelerated from a 1930's style contraction to the low single-digits near typical post-war recession lows. Credit is still contracting in Europe and Japan.

But there is still a sizable group within the FOMC insistent the economy has not changed since Alan Greenspan codified the Federal Reserve's playbook in the mid-Nineties. They smell wage growth and want to limit growth before it causes inflation to overheat. However, many economists believe the Fed has tightened prematurely every time it has raised rates since 2004.

Low rates still work here. The Fed was able to raise the funds rate a quarter-point last year and, despite some first-quarter hiccups, credit and the economy are still growing. In Japan, rates have been negative and no one wants to borrow. Japan is suffering from many of the same long-run economic problems we are. But they fell into it years before we did. In the near three decades since the Nikkei collapse in 1989, marking the end of their credit bubble, the Japanese economy has shown real promise many times, only to be tripped up by over-eager policy makers trying to normalize interest rates and fiscal spending. The BOJ had no one to show them what to do. But the Fed can learn from the BOJ's mistakes.

There is a core group in the Fed who have not realized how much like Japan the US has become. But the rapid decline in the Fed's forecasting accuracy this year suggests most of the FOMC is figuring it out.

Yellen's decision to defy rate hike hawks may mark a turning point, effectively the start of the Yellen Fed, when they set aside Bernanke's plan to "normalize" rates in favor of a little more inflation and wage growth.

*My friend received a life insurance settlement check shortly after the death of her husband. Will she have to pay income taxes on this?*

Probably not. The funds paid to a beneficiary from a life insurance policy are not considered taxable income. Nowadays, there are life insurance policies that can have funds available to the living, as well as the tax-free funds for their heirs. It's easy to see why more and more folks are using life insurance as an investment to potentially have money to use during their lifetime as well as taking care of their beneficiaries.

*I've been getting SO MANY phone calls and so much mail about enrolling in various Medicare Supplement and Prescription drug programs. How can I know if these guys are for real or if they are fakes?*

If you suspect that you are being taken advantage of, have questions about an insurance offer, scheme, or agent, call the Dept. of Insurance 1-800-927-4357, or go to [www.insurance.ca.gov](http://www.insurance.ca.gov). Here are some tips: 1. Make sure the person is a licensed insurance agent. 2. Don't accept uninvited sales calls of any kind. 3. Never give out personal information (Social Security number, bank account numbers, or credit card information over the phone. 4. Be aware: Medicare has no official sales reps. 5. Federal regulations prohibit marketing of Medicare products wherever

healthcare is delivered. 6. Federal regulations prohibit offering free meals for listening to a sales presentation or for signing up in a particular plan. 7. Federal regulations prohibit selling additional insurance products during any sales or marketing presentation for a Medicare Advantage or prescription drug plan. 8. Read and understand the plan.

*My sister just entered a nursing and rehab center to get her strength back and get some rehab from having a mild stroke. Now she's being told that if she'd spent 3 days in a hospital first, then got doctor's orders to go to a nursing home, Medicare would pay up to 80-percent of the bill. However, since she didn't have a hospital stay, Medicare will pay nothing. She's a vet, but never got her VA card. She has no long-term care insurance, and no life insurance. What do we do now?*

Her medical doctor should be aware of the 3-day-hospitaliza-

tion rule; talk to him about the situation. As far as getting her VA Medical Card, she needs to find out where her local office is, and either present her 214 Discharge papers, (or they can probably find her in the system), and fill out an application. Make an appointment with a VA patient advocate.

*Last year we had to pay capital gains on our mutual funds distributions. Is there a way to decrease the amount of capital gains tax we have to pay?*

With investments like mutual funds, stocks, CDs, and savings, your earnings are taxed annually. You might want to consider moving at least some of your mutual funds dollars to a tax-deferred investment, or to an insurance product. With a tax-deferred investment, you'll pay taxes only when you withdraw funds. Some insurance products offer "loans" which are not taxable, and which could be re-paid from the death benefit.

# 17 Ballot Initiatives ... Confused?

Not only my kids but others, all adults, some graduated college, have asked for basic information on the ballot initiatives ... like how do I vote on 17 ballot initiatives? Others say I'm retired and I don't have that much time! And confusing? Oh, my, yes it is very confusing! Especially when you have two death penalty issues and two plastic bag initiatives.

Let me try to give you the conservative perspective ... and, yes, with some conflicted opinions. But let's at least give a try at giving you some help, ok?

First, a list of acronyms:

- CAGOP - California Republican Party
- RPLAC - Republican of Los Angeles County
- CRRW - California Republican Women Federated
- LACFRW - Los Angeles County Federation of Republican Women
- CRA - California Republican Assembly
- Mt View - Mt View Republicans
- Pasa Rose - Pasadena Rose Republicans
- Tea Party - Chino Freedom & Redlands
- Cal Tax - California Taxpayers
- HJTA - Howard Jarvis Taxpayers

**Prop. 51**

A \$9 billion school bond for K-12 and Community College Facilities but it will ultimately cost about \$17.6 billion to pay off both the principal and interest (\$8.6 billion in interest) Payments are estimated at \$500 million per year for 35 years with payments escalating at the end. This is money that comes out of the general fund and could affect law enforcement support the state general fund provides.

Be aware - June 7th ballot had 40 school bonds to vote on with the majority approved and there are at last count 28 school bond measures proposed for the November ballot. The first question to ask - Why is all this money asked for to be dumped into education facility improvements? Where is it going and is it all improving education?

Yes Vote: CAGOP, RPLAC, CalTax. No Vote: Jerry Brown.

LACFRW, CRA, Mt View, Pasa Rose, Tea Party, HJTA. No Position: CFRW.

**Prop 52**

**Medi-Cal Hospital Reimbursement** adds language to the California Constitution to require voter approval of changes to the hospital fee program to make it harder for the legislature to divert these funds from the original intended purpose of supporting hospital care to Medi-Cal patients and to help pay for healthcare for low-income children.

Yes Vote: CAGOP, RPLAC, CFRW, LACFRW, Mt View. No Vote: CRA, PasaRose, Tea Party. No Position: CalTax, HJTA.

**Prop 53**

No Blank Checks Initiative would require any bond of \$2 billion or more for a state project to go before the voters for approval.

All support a yes vote with CalTax taking no position.

**Prop 54**

Requires every bill be published in print and online at least 72 hours before each house of the legislature can vote on it and allows recording of open legislative proceedings.

Yes Vote: All. No Vote: None.

**Prop 55**

Tax Extension to Fund Education & Health Care would continue the so-called temporary tax rates instituted by Proposition 30 through 2030.

No Vote: All.

**Prop 56**

Cigarette Tax is currently \$0.87 per pack and a yes vote would raise the tax another \$2.00 a pack.

No Vote: All.

**Prop 57**

Is another early release proposal to relieve prison over-crowding. It would also allow judges, not prosecutors, to decide whether to try certain juveniles as adults in court.

No Vote: All except Cal Tax and HJTA who took No Position.

**Prop 58**

This proposal would no longer require English-only education for English learners.

No Vote: All except CalTax and HJTA who took No Position.

**Prop 59**

Citizens United, a Supreme Court decision, ruled corporations had a 1st amendment right to spend unlimited amounts of money to influence elections. Prop 59 calls on California's elected officials to work on overturning that decision including a constitutional amendment. This is advisory only.

No Vote: All except CalTax and HJTA who took No Position.

**Prop 60**

This would require adult film producers to provide condoms and ensure that performers use them during certain performances.

No Vote: All except LACFRW, CalTax and HJTA who took No Position.

**Prop 61**

This would require state agencies to pay the same prices the US Dept. of Veteran Affairs pays for prescription drugs.

No Vote: All except HJTA who took No Position.

**Prop 62**

This repeals the death penalty and replaces the maximum punishment for murder with life in prison without possibility of parole. It would apply retroactively to those already sentenced to death and would require those sentenced to pay restitution to victims.

No Vote: All except CalTax and HJTA who took No Position

**Prop 63**

Requires individuals who wish to purchase ammunition to first obtain a permit. Dealers would be required to check this permit before selling ammunition.

No Vote: All except CalTax and HJTA who took No Position

**Prop 64**

Marijuana legalization

No Vote: All except CalTax and HJTA who took No Position

**Prop 65**

This redirects money collected from the sale of carry-out plastic bags by grocery or other retail stores to a special fund administered by the Wildlife Conservation Board.

Yes Vote: RPLAC, CRA. No Vote: CAGOP, CFRW, LACFRW, Mt View, Tea Party, CalTax. No Position: HJTA

**Prop 66**

Changes the way we deal with death penalty cases. Trial courts would initially be in charge; death row inmates would be housed in any prison; and appeals completed within 5 years after sentencing. Inmates required to work with 70% of earnings going to victims.

Yes Vote: All except CalTax and HJTA who took No Position.

**Prop 67**

This would uphold the contested legislation banning plastic bags under Senate Bill 270.

No Vote: All except CalTax and HJTA who took No Position.

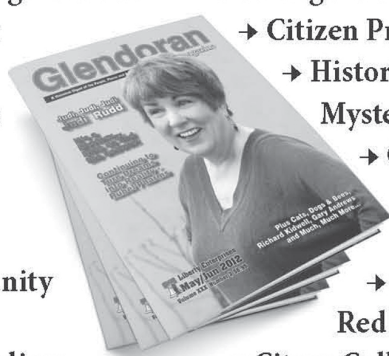

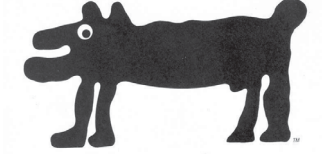
