# Camping? Make Sure to Travel a Well-Lit Path

Whether your escape to nature involves a day of hiking, tenting overnight or RVing, a little planning will go a long way in making your experience enjoyable.

You know, of course, to bring graham crackers and marshmallows, but your light source can make or break your trip.

Most of us are used to seeing streetlights and headlights at night -- it's easy to forget how dark it gets in the woods. Every camper should carry a flashlight. You will also need a larger light that provides enough illumination to work by. Most people associate propane lanterns with the great outdoors, but these lanterns aren't necessarily the best option. Propane lanterns can be noisy and cannot be used in tents or campers, and you will need to pack and carry fuel. Because propane lanterns produce heat, they are a burn hazard.

LED worklights provide a safer and easier option. One light, the Might-D-Light (www.might-d-light.com), proves especially useful, as its hinge can be moved to create either a large spray of light or directional lighting for close work. # Public Invited To Weigh In On Cannabis Regulations In L.A. County

**LOS ANGELES COUNTY** - Following voters' legalization of recreational cannabis in California, L.A. County has embarked on an extensive listening tour to find out what residents of unincorporated areas would like to see in upcoming regulations.

Eighteen workshop-style listening sessions have been scheduled this summer in communities across the county, from the Antelope Valley to Willowbrook.

The first is scheduled for Thursday, July 13, from 6:30 p.m. to 8:30 p.m. at the Topanga Library. For a full list of upcoming sessions, go to: Cannabis.lacounty.gov

Topics to be discussed include rules for cannabis busi-

nesses, rules for the cultivation of cannabis for personal use, taxation and revenue, and youth access and exposure, among others. Translation services will be available.

In November 2016, California voters approved Proposition 64, which legalized the possession, cultivation, and sale by adults of cannabis for nonmedical purposes. Proposition 64 also established a regulatory framework for commercial cannabis businesses, including cultivators, edibles manufacturers and dispensaries.

Following the passage of Proposition 64, the Los Angeles County Board of Supervisors directed County departments to develop regulations for cannabis in unincorporated

Los Angeles County.

The listening sessions will provide valuable public input in the development of those regulations.
