Each bid shall be accompanied by Bidder's Security in an amount equal to at least ten (10) percent of the bid amount, which security shall be lawful money of the United States of America and in one of the following forms: (i) cash, (ii) cashier's check made payable to the City, (iii) certified check made payable to the City, or (iv) bid bond executed by an admitted surety insurer and made payable to the City. Bid Bond form must be used.

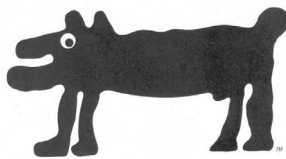

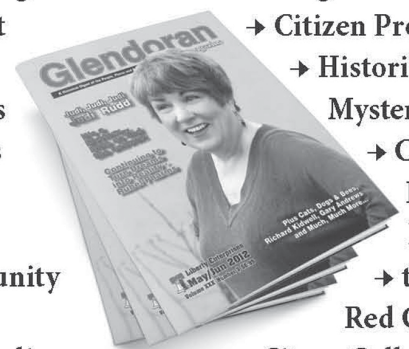
