ORDINANCE 18-13**AN URGENCY ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COVINA, CALIFORNIA, ENACTED PURSUANT TO GOVERNMENT CODE SECTION 65858 EXTENDING A MORATORIUM ON ISSUING ANY PERMITS FOR ANY NEW RECYCLING COLLECTION FACILITIES, OR THE RE-OPENING OF ANY PREVIOUSLY APPROVED BUT CURRENTLY CLOSED RECYCLING COLLECTION FACILITIES, OR THE EXPANSION OF ANY EXISTING RECYCLING COLLECTION FACILITIES, DECLARING THE URGENCY THEREOF, AND MAKING A DETERMINATION OF EXEMPTION UNDER THE CALIFORNIA ENVIRONMENTAL QUALITY ACT****THE CITY COUNCIL OF THE CITY OF COVINA DOES ORDAIN AS FOLLOWS:**

SECTION 1. Purpose and Intent. The City of Covina intends to ensure that the City's commercially zoned areas maintain an appropriate and balanced mix of commercial and retail uses so as to maintain a vibrant and healthy local economy. In addition, the City of Covina intends to ensure that residential and other commercial uses adjacent to Recycling Collection Facilities are protected and will not experience detrimental impacts associated with the operation of a Recycling Collection Facility. A review of Covina Municipal Code (CMC) indicates that regulations and development standards related to Recycling Collection Facilities are either outdated or lack clarity. The City intends to establish a moratorium on the development and operation of new Recycling Collection Facilities, the re-opening of any previously approved but currently closed Recycling Collection Facility or the expansion of any existing Recycling Collection Facility, for the period of time as specified in this Ordinance, so as to permit further study of the City's zoning regulations.

SECTION 2. The City Council finds that the facts set forth in the Recitals of this Ordinance are true and correct.

SECTION 3. Public Hearing. On December 18, 2018, the City Council held duly noticed public hearing regarding the proposed extension of the urgency ordinance, and after taking all written and oral testimony, closed the public hearing.

SECTION 4. Written Report Supporting Extension. On December 13, 2018, the City prepared and made available for public review a written report regarding the status of the City's moratorium prohibiting the development and operation of new Recycling Collection Facilities, the re-opening of any previously approved but currently closed Recycling Collection Facility or the expansion of any existing Recycling Collection Facility.

SECTION 5. Moratorium Extended. This Interim Ordinance shall become operative concurrent with the expiration of Covina Ordinance 18-11. The moratorium enacted pursuant to City of Covina Ordinance 18-13 is hereby extended pursuant to Government Code Section 65858 for ten (10) months and fifteen (15) days past the initial expiration date of Covina Ordinance 18-11 so as to extend the moratorium until October 28, 2019. Therefore, this Interim Ordinance shall expire and terminate at midnight on October 28, 2019, unless it is further extended.

SECTION 6. Legislative Findings.

A. On December 18, 2018, the City Council considered the adoption of this Urgency Ordinance at a duly noticed public meeting and on the basis of the record thereof makes the following findings in support of the immediate adoption and application of this Urgency Ordinance regulating land use within the City.

B. The City is responsible for adopting and implementing land use regulations within its boundaries. The portion of the Covina Municipal Code (CMC) regulating Recycling Collection Facilities, which has not been comprehensively updated since 1987, generally regulates the entitlement, establishment and operation of Recycling Collection Facilities within the City. Section 17.62.195.A.2 of the CMC defines a "Recycling facility" is a center for the collection and/or processing of recyclable materials. A certified recycling facility or certified processor means a recycling facility certified by the California Department of Conservation as meeting the requirements of the California Beverage Container Recycling and Litter Reduction Act of 1986. A recycling facility does not include storage containers or processing activity located on the premises of a residential, commercial, or manufacturing use and used solely for the recycling of material generated by that residential property, business or manufacturer.

C. Over time, recycling center businesses have established in the City, located on commercially zoned properties, but adjacent to residential zones and non-retail commercial uses. Since 1987, the character of the properties where Recycling Centers are located, as well as adjacent properties, has changed significantly, including operational characteristics of recycling centers. A General Plan goal and policy is to encourage the capturing of a greater variety of retail stores, shops, and restaurants to attract more patrons, generate sales tax and further improve the community's image (General Plan, Chapter III3a13). It is therefore necessary to update the CMC to adopt appropriate land use regulations, aesthetic criteria, operating standards and security criteria, in order to ensure and maintain quality commercial areas. Another General Plan goal and policy (Chapter III 3a7) is to "accommodate new and expanded commercial and industrial developments, for community betterment and image enhancement and related reasons, in a fashion that neither adversely affects the integrity of established commercial and/or industrial areas nor unreasonably encroaches into residential neighborhoods and that not impose an undue burden on local infrastructure or services." Because it is the intent of the general plan to expand the variety of commercial and retail stores available in the City, therefore, there is a need to update the CMC to address and expand this particular retail land use category.

D. There is a current and immediate threat to the public health, safety and welfare presented by the establishment of new recycling collection facilities, the re-opening of any previously approved but currently closed recycling collection facility, or the expansion of any existing recycling collection facility. Without establishing appropriate zoning regulations within the various Commercial Zones that could accommodate this particular type of land use category, it would be inconsistent with the General Plan goals and policies of capturing a greater variety of retail stores and a providing a balanced mix of retail stores.

E. The City Council finds that additional planning and research are necessary to study the adequacy of its existing ordinances before the City adopts any regulation governing new recycling collection facilities, the re-opening of any previously approved but currently closed recycling collection facility, or the expansion of any existing recycling collection facility. The City requires a sufficient and reasonably limited time to consider and study legally appropriate and reasonable policies regulating this business activity in order to prevent negative impacts on City residents, businesses and visitors. The City intends to undertake such a study within a reasonable time. Given the time required to undertake the study and planning, the City Council finds that it is necessary that this urgency moratorium be declared to ensure that no new recycling collection facilities, the re-opening of any previously approved but currently closed recycling collection facility, or the expansion of any existing recycling collection facility that may be in conflict with the contemplated new development or use policies are permitted in the interim.

F. Absent the passage of this Urgency Ordinance, continued approval of entitlements for new recycling collection facilities, the re-opening of any previously approved but currently closed recycling collection facility, or the expansion of any existing recycling collection facility poses a current and immediate threat to the public health, safety or general welfare. If this Urgency Ordinance does not become effective immediately, but instead becomes effective thirty (30) days after a second reading, there is a risk that further harm will be done to prevent the orderly development of new recycling collection facilities, the re-opening of any previously approved but currently closed recycling collection facility, or the expansion of any existing recycling collection facility in the City. There is therefore an urgent necessity for the City to adopt a moratorium on the establishment of new recycling collection facilities, the re-opening of any previously approved but currently closed recycling collection facility, or the expansion of any existing recycling collection facility to take effect immediately. This moratorium is intended to provide the City with an opportunity to strengthen its zoning provisions to promote an appropriate and healthy mix of commercial retail uses in the City.

G. For the reasons specified in above, and based on all the evidence in the record, the City Council finds that there is a current and immediate threat to the public health, safety and welfare presented by the unregulated development or operation of new recycling collection facilities, the re-opening of any previously approved but currently closed recycling collection facility, or the expansion of any existing recycling collection facility in the City that would be inconsistent with the City's land use goals. In the absence of immediate effectiveness, the approval of building permits or any other applicable entitlements for such development or use or will frustrate the City's ability to adopt and enforce appropriate regulations

designed to protect surrounding development, use, and the public health, safety, and welfare from the potentially adverse effects of new recycling collection facilities, the re-opening of any previously approved but currently closed recycling collection facility, or the expansion of any existing recycling collection facility. Due to the foregoing circumstances, the City Council finds and determines that the immediate preservation of the public health, safety, and welfare requires that this Urgency Ordinance be enacted as an urgency ordinance pursuant to Government Code Section 65858, that it take effect immediately upon adoption, and that its urgency is hereby declared.

SECTION 7. CEQA Finding. The City Council hereby finds that it can be seen with certainty that there is no possibility the adoption of this Urgency Ordinance will have a significant effect on the environment because the adoption of this Urgency Ordinance will maintain the current environmental conditions arising from the current land use regulatory structure as adopted by the City, will preclude the establishment of a category of uses for a limited period of time, and will serve to reduce potential significant adverse environmental impacts caused by the establishment of any new recycling collection facilities, the re-opening of any previously approved but currently closed recycling collection facility, or the expansion of any existing recycling collection facility. The City Council therefore determines that the adoption of this Urgency Ordinance and the effects derivative from its adoption are exempt from California Environmental Quality Act review pursuant to Title 14, Section 15061(b)(3) of the California Code of Regulations.

SECTION 8. Moratorium Established.

A. Based upon the findings contained in Section 6, the City of Covina hereby establishes a moratorium on the development or operation of new recycling collection facilities, the re-opening of any previously approved but currently closed recycling collection facility, or the expansion of any existing recycling collection facility in the City.

B. For purposes of this Urgency Ordinance, the terms, "recycling collection facility", "recycling center" and/or "recycling facility" is a center for the collection and/or processing of recyclable materials. A certified recycling facility or certified processor means a recycling facility certified by the California Department of Conservation as meeting the requirements of the California Beverage Container Recycling and Litter Reduction Act of 1986. A recycling facility does not include storage containers or processing activity located on the premises of a residential, commercial, or manufacturing use and used solely for the recycling of material generated by that residential property, business or manufacturer.

C. For purposes of this Urgency Ordinance, the term "recyclable material" is reusable material including but not limited to metals, glass, plastic and paper, which are intended for reuse, remanufacture, or reconstitution for the purpose of using the altered form. Recyclable material does not include refuse or hazardous materials. Recyclable material may include used motor oil collected and transported in accordance with Sections 25250.11 and 25143.2(b)(4) of the California Health and Safety Code.

D. For purposes of this Urgency Ordinance, the term "new" shall mean any recycling collection facility, recycling facility or recycling center in the City that has not obtained approval of the land use from City's Planning Division and a building permit from City's Building Division or operation in its present location prior to the effective date of this Ordinance.

SECTION 9. Moratorium Defined. Notwithstanding any other ordinance or provision of the CMC:

A. The establishment or operation of any new recycling collection facilities, the re-opening of any previously approved but currently closed recycling collection facility, or the expansion of any existing recycling collection facility, is prohibited during the term of the moratorium established in Section 8 above.

B. The City shall not approve any new or pending application for any permit, license or other entitlement for the establishment, operation or expansion of any new recycling collection facilities, the re-opening of any previously approved but currently closed recycling collection facility, or the expansion of any existing recycling collection facility during the term of the moratorium established in Section 8 above.

SECTION 10. Exceptions. This Urgency Ordinance and the moratorium enacted hereby shall not affect any existing recycling collection facility previously approved and in uninterrupted operation pursuant to the CMC that do not seek an expansion in use. All existing recycling collection facilities permittees shall comply with the requirements of the CMC and the terms and conditions of any permit issued pursuant thereto.

SECTION 11. Immediate Effect. This Urgency Ordinance is an urgency ordinance for the immediate preservation of the public peace, health, and safety within the meaning of Government Code Section 36937(b) and therefore shall be passed immediately upon its introduction and shall become effective immediately upon its adoption, by a minimum four-fifths (4/5) vote of the City Council.

SECTION 12. Penalty. A violation of any provision of this Urgency Ordinance shall constitute a misdemeanor and shall be punishable by a fine not to exceed One Thousand Dollars (\$1,000) or by imprisonment for a period not to exceed six (6) months, or by both such fine and imprisonment. Each and every day such a violation exists shall constitute a separate and distinct violation of this Ordinance. In addition to the foregoing, any violation of this Ordinance shall constitute a public nuisance and shall be subject to abatement as provided by all applicable provisions of law.

SECTION 13. Planning Studies and Written Report. The City staff shall promptly commence the studies they may deem necessary and appropriate to make recommendations to this City Council regarding the development, use and expansion of recycling collection facilities in the City and the criteria for regulating these uses. Pursuant to Government Code Section 65858(d), City staff shall prepare and submit for City Council adoption, at least ten (10) days prior to the expiration of this Urgency Ordinance, or any extension hereof, a written report describing the measures taken to alleviate the conditions that led to the adoption of this Urgency Ordinance.

SECTION 14. Severability. If any section, subsection, subdivision, paragraph, sentence, clause, or phrase of this Urgency Ordinance or any part thereof is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining portions of this Urgency Ordinance or any part hereof. The City Council of the City of Covina hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase hereof, irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared invalid.

SECTION 15. Publication and Posting. The City Clerk shall certify to the passage and adoption of this Urgency Ordinance and shall cause the same or a summary thereof to be published and posted in the manner required by law.
