ORDINANCE NO. 2026

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GLENDORA, CALIFORNIA, AMENDING TITLE 21 (ZONING) OF THE MUNICIPAL CODE TO ALLOW PERIMETER FENCES AND WALLS TALLER THAN SIX FEET FOR PUBLIC FACILITIES (PLN17-0037).

THE CITY COUNCIL
City of Glendora, California

THE CITY COUNCIL OF THE CITY OF GLENDORA DOES HEREBY ORDAIN AS FOLLOWS:

WHEREAS, on September 12, 2017, the City Council initiated a zoning text amendment to allow fences and walls to exceed six feet in height at public/civic facilities; and
WHEREAS, a public hearing on the Proposed Amendment was held before the Planning Commission on November 7, 2017, after due notice was given as required by law, at which time oral and documentary evidence was introduced along with the written recommendation of the Planning Director; and
WHEREAS, a public hearing on the Proposed Amendments was held before the City Council on December 12, 2017, after due notice was given as required by law, at which time oral and documentary evidence was introduced along with the written recommendation of the City Council and of the Planning Director; and
WHEREAS, the City Council finds and determines that the public necessity, convenience, general welfare and good zoning practice requires the Proposed Amendment, and that the Proposed Amendment is consistent with the General Plan.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENDORA, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

- SECTION 1. The City Council finds that the adoption of this Ordinance is not subject to environmental review under the California Environmental Quality Act (CEQA) because the revisions to the Municipal Code are an activity that will not result in a direct or reasonably foreseeable indirect physical change in the environment. Since it can be seen with certainty that there is no possibility that the Zoning Ordinance text amendments have the potential to have an adverse effect on the environment, the City Council adopts a General Rule Exemption from CEQA pursuant to Section 15061(b)(3) of the State CEQA Guidelines.
SECTION 2. Section 21.03.010.F.2 of the Glendora Municipal Code is hereby repealed and replaced as follows:
21.03.010 – Property Development Standards
"0. Fences and walls not exceeding six feet in height shall be permitted behind the front yard setback. Fences and walls exceeding six feet in height may be permitted at public facilities, subject to approval by the City Council."
SECTION 3. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unenforceable by a court of competent jurisdiction, the remaining portions of this Ordinance shall nonetheless remain in full force and effect. The people of the City of Glendora hereby declare that they would have adopted each section, subsection, sentence, clause, phrase, or portion of this Ordinance, irrespective of the fact that any one or more sections, subsections, sentences, clauses, phrases, or portions of this Ordinance be declared invalid or unenforceable.
SECTION 4. The Mayor shall sign this Ordinance and the City Clerk shall attest and certify to the passage and adoption thereof and cause same to be published at least once in the San Gabriel Valley Examiner, a weekly newspaper of general circulation, published in the City of Glendora, which newspaper is hereby designated for that purpose (GC § 40806); and thereupon, and thirty (30) days after its passage, this ordinance shall take effect and be in force.

The following Section of Title 21 of the Glendora Municipal Code is hereby amended as follows

F. Fences and Walls. Fences and walls shall be permitted and/or required as specified in this subsection:

Fences and walls shall be articulated with either a jog, which measures a minimum of eighteen inches deep by eight feet wide, or other architectural treatment at least eight feet wide;
d. Walls adjacent to the Gold Line railroad right-of-way may be up to eight feet in height for noise attenuation purposes. Walls greater than eight feet in height may be permitted subject to the preparation of an approved noise study by an acoustical engineer.

The replica Wall is approximately 250 feet in length, and like the original Memorial is erected in a chevron-shape.

The replica is constructed of powder-coated aluminum, supported by an aluminum frame, and is made up of 24 individual panels, each containing six columns of names.

The names on The Wall That Heals replicate the names on The Wall in Washington, D.C. As on the Wall, the names are listed alphabetically by day of casualty. Beginning at the center/apex, the names start on the East Wall (right-hand side) working their way

out to the end of that wing, picking up again at the far end of the West Wall (left-hand side) and working their way back in to the center/apex. Thus, the beginning and ending of the conflict are joined at the center, signifying an epoch in American history.

The Wall That Heals is transported from community to community by a trailer with cases built into its sides, allowing it to serve as a mobile Education Center that tells the story of the Vietnam War, The Wall and the divisive era in American history.

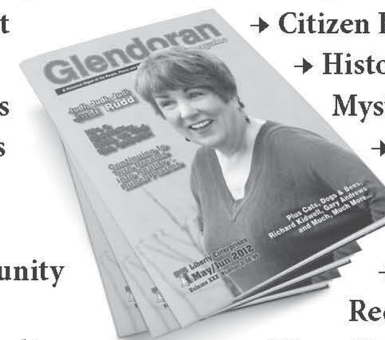
