Synopsis of Measure CC

Measure CC is an ordinance submitted to the voters of the City of Covina by the City Council. It adopts a retail transactions and use tax on the sales of goods in the City, and the taxable storage, use or consumption in the City of goods purchased. It will take effect only if approved by a majority of the voters voting thereon.

If approved by the voters, Measure CC would increase the City's existing sales tax rate by 0.75%, or 3/4 of one cent, on every dollar of taxable sales of goods in the City, and the taxable storage, use or consumption in the City of goods purchased. Measure CC provides that the tax will be collected by the State of California under a contract in the same way the existing sales tax is collected. The total sales tax rate paid in Covina, which also includes the sales tax collected for the State of California and other public agencies, is 9.5% now. If Measure CC is approved by the voters, the total sales tax rate in the City will increase to 10.25% subject to any changes in state law.

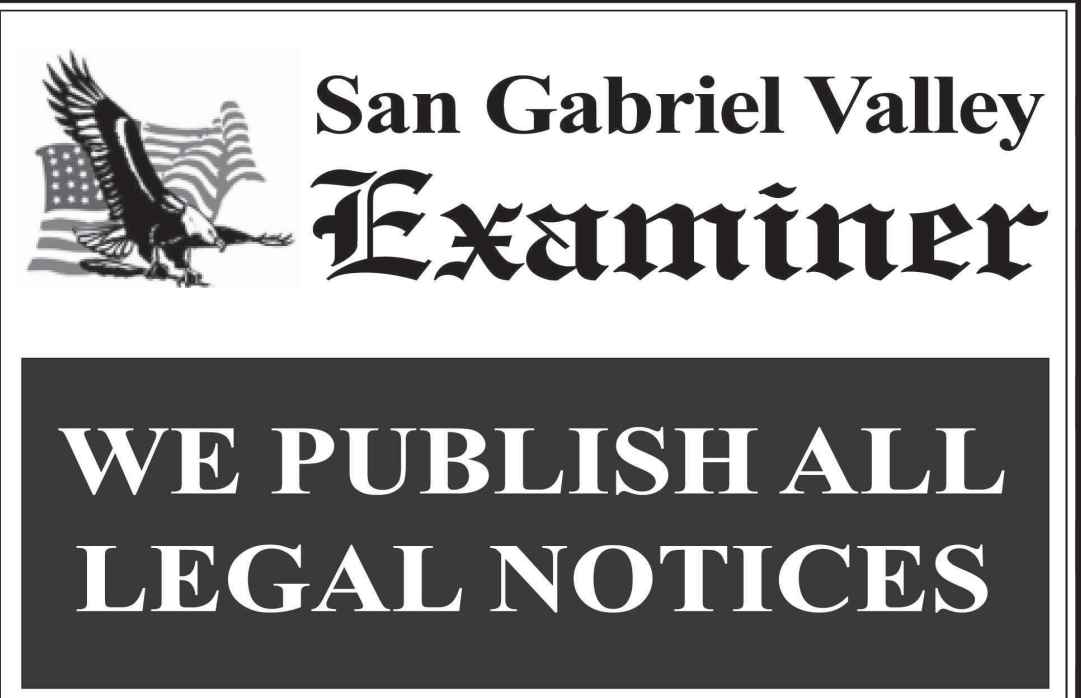
