NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF COVINA, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council of the City of Covina does hereby declare its intent to levy and collect assessments in the BAED for fiscal year 2020-21 in the time and manner specified in the ordinance which established the BAED.

SECTION 2. The boundaries of the BAED shall remain as established.

SECTION 3. The type of improvements and activities to be funded by the levy of assessments on the businesses in the BAED may include, but are not limited to, the following:

- a) safety and security programs
b) parking facilities
c) benches
d) trash receptacles
e) street lighting
f) decorations
g) parks
h) fountains
i) promotion of public events which benefit businesses in the area and which take place on or in public places within the area
j) furnishing of music in any public place in the area
k) promotion of tourism within the area
l) activities which benefit businesses located and operating in the area

No substantial changes will be made to this list of improvements and activities.

SECTION 4. The name of the Parking and Business Improvement Area under which this levy and collection is carried out is the Covina Prospero Park Business Area Enhancement District ("BAED"). The boundaries of the Prospero Park BAED include all apartment buildings south of San Bernardino Road, north of Badillo Street, east of Barranca Avenue and west of Forestdale Avenue.

SECTION 5. A full and detailed description of the improvements and activities to be provided for fiscal year 2020-21, the boundaries of the BAED and any benefit zones within it, and the proposed assessments to be levied upon the businesses within the BAED for that fiscal year can be found in the Advisory Board's report on file with the City Clerk.

SECTION 6. The City Council hereby establishes the regularly scheduled City Council meeting of December 1, 2020, at 7:30 p.m. as the time and place for a public hearing on the levy of the proposed assessments for fiscal year 2020-21. At this public hearing, protests may be made orally or in writing by any interested person. Any protest pertaining to the regularity or sufficiency of these proceedings shall be in writing and shall clearly set forth the irregularity or defect to which the objection may be made. Any protest made must comply with the provisions of California Streets and Highways Code section 36524 and 36525.

SECTION 7. The City Clerk shall give notice of the public hearing by causing this Resolution of Intention to be published once in a newspaper of general circulation in the City at least seven days before the public hearing.

SECTION 8. The City Clerk shall certify as to the adoption of this resolution and shall enter the same in the Book of Original Resolutions.
