CITY OF COVINA NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the City Council of the City of Covina will conduct a public hearing for the public to provide input regarding the content of the draft map or maps and the proposed sequencing of elections with respect to the City's transition to a district-based election system in the City Council Chambers, 125 E. College Street, Covina, CA 91723 on the following date:

- Tuesday, December 21, 2021 at 7:30 p.m. or as soon thereafter as the matter can be heard

The City of Covina currently elects its City Councilmembers through an "at-large" election system in which each Councilmember can reside anywhere in the City and is elected by the voters of the entire City to provide city-wide representation. On October 21, 2021, the City Council adopted a resolution declaring its intent to transition from at-large to district-based Councilmember elections. In a district-based election system, the City would be divided into smaller geographic districts and voters residing in each district would elect a single member to represent them on the City Council.

The hearing listed above will be the third of four (4) public hearings concerning a transition from at-large Council elections to district-based Council elections as set forth in Elections Code Section 10010. At least one map of the proposed Council districts and the sequence of elections will be available for public review starting on December 13, 2021 at the following locations in the City of Covina:

- 1. City Hall, 125 E. College Street; and
2. On the City's website at: mapcovina.org

The public is encouraged to attend the public hearing and comment on the matter described above either in person at the City Council chambers or in real time via Zoom. To access the live Zoom meeting, use the Zoom link, Meeting ID, and Meeting Passcode listed on the Council meeting agenda, which can be found at https://covinaca.gov/meetings or mapcovina.org/schedule 72 hours before each public hearing date listed above. To request to speak during public comment, please click the "Raise Hand" button on the Zoom toolbar. Public testimony is limited to five (5) minutes per speaker. A speaker's time may not be transferred to another speaker.
