RESOLUTION NO. 4
RESOLUTION OF THE BOARD OF EDUCATION OF THE GLENORA UNIFIED SCHOOL DISTRICT DECLARING ITS INTENT TO LEASE SURPLUS REAL PROPERTY

WHEREAS, the Glendora Unified School District (the "District") is the owner of certain real property, commonly known as the Goddard Middle School, located at 859 E. Sierra Madre Avenue, in the City of Glendora, County of Los Angeles, State of California (the "School"); and
WHEREAS, approximately two thousand five hundred (2,500) square feet of property located adjacent to the tennis courts located in the northeast portion of the School as more particularly described on Exhibit "A" attached hereto (the "Property"), is not needed by the District for school classroom buildings; and
WHEREAS, this Board desires to consider proposals for the lease of the Property to be used exclusively for mobile/wireless communications services; and
WHEREAS, the successful bidder shall submit a proposal to include the Property subject to lease pursuant to the provisions of Education Code Sections 17455 through 17478.
NOW, THEREFORE, the Board of Education hereby resolves:
1. That this Board hereby determines that the Property is not and will not be needed by the District for school classroom buildings at the time of delivery of possession.
2. That the Board declares its intention to receive and consider proposals for the lease of the Property in accordance with the provisions of Education Code Section 17455 et seq., together with required non-exclusive easements.
3. The initial Option Term for the Option and Ground Lease Agreement (the "Agreement") shall be an Option Term for one (1) year. The initial Option Term of the Agreement may be extended up to three (3) additional consecutive Option Terms of one (1) year each. The initial minimum annual written bid for the Option Term and each available Option Term Extension shall be One Thousand Four Hundred Dollars (\$1,400.00) per year.
4. The successful bidder shall use the Property exclusively for the purpose of constructing, maintaining, securing and operating mobile/wireless communications services, consistent with the terms of the Agreement for the Property.
5. The initial Lease Term for the Agreement shall be a Lease Term of five (5) years. The initial Lease Term of the Agreement may be extended for up to nine (9) additional consecutive renewal terms of five (5) years each.
6. The successful bidder shall submit with its bid a certified or cashier's check made payable to the District in the amount of One Thousand Four Hundred Dollars (\$1,400.00) as bid security for entering into the Agreement. The deposit of the successful bidder will be retained by the District and applied toward the initial Option Term due under the terms of the Agreement. All other deposits will be returned.
7. The initial minimum annual written bid for the Lease of the Property shall be Twenty-Four Thousand Dollars (\$24,000.00), payable in equal monthly installments of Two Thousand Dollars (\$2,000) each. On each anniversary of the Lease, during the first five renewal terms, the rental amount shall be increased by an amount equal to three percent (3%) of the rent in effect for the last month of the previous year.
8. Bid proposal forms along with the proposed Agreement may be obtained from the Business Department of the Glendora Unified School District, located at 500 N. Loraine Avenue, Glendora, California, 91741.
9. Bid proposals for the lease of the Property shall be sealed and submitted to the Business Department of the Glendora Unified School District on or before the hour of 7:00 p.m. on Monday, November 13, 2017, before the public hearing commences at the District Board Room located at 500 N. Loraine Avenue, Glendora, California 91741.
10. At the time set for the public hearing, the sealed bid proposals shall be opened, examined and declared. Oral bids will then be called for. If, upon the call for oral bidding, any responsible person offers to enter into said Agreement, upon the terms and conditions specified and for a price exceeding by at least five percent (5%) the highest written bid proposal for the lease of the Property, then the oral bid which is the highest shall be finally accepted. Final acceptance shall not be made however until the oral bid is reduced to writing and signed by the offeror and a certified or cashier's check made payable to the District in the amount of Five Thousand Dollars (\$5,000.00) as bid security is submitted.
11. The final acceptance of the highest responsible bid proposal, either written or oral, will be made at or after the November 13, 2017 Board of Education meeting or at any adjourned session of the same meeting held within ten (10) days next following. The Board may select the highest bid of any of the bids or, if it deems such action to be for the best public interest, it may reject any and all written or oral bids.
12. The District will not pay commissions on the Property subject to the Agreement.
13. The Superintendent of this District or his designee is hereby authorized and directed to give notice of the Board's intent to lease the Property by posting copies of this Resolution signed by the Board or a majority of it, in three (3) public places in District not less than fifteen (15) days before the date of the meeting in which sealed proposals to lease the Property will be received and considered, and by publication of a Notice of Lease not less than once a week for three (3) successive weeks before the date of the meeting in a newspaper of general circulation published in the District or in Los Angeles County and having a general circulation in the County.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GLENORA ESTABLISHING AND IMPLEMENTING BY-DISTRICT ELECTIONS PURSUANT TO GOVERNMENT CODE §34886 AND ELECTION CODE §10010

THE CITY COUNCIL
City of Glendora, California

WHEREAS, the City of Glendora supports the full participation of all citizens in electing members of the City Council; and
WHEREAS, the City of Glendora currently elects its five (5) members of the City Council using an at-large election system, where candidates may reside in any part of the City and each member of the City Council is elected by the voters of the entire City; and
WHEREAS, California Government Code Section 34886, effective January 1, 2017, permits the City Council of any city to change the City's method of election by ordinance to a "by-district" system in which each member of the City Council is elected only by the voters in the district in which the candidate resides; and
WHEREAS, under the provisions of California Elections Code Section 10010, a city that changes from an at-large city council method of election to a by-district city council method of election requires a total of five public hearings, which includes at least two public hearings regarding potential voting district boundaries prior to the release and consideration of any draft voting district maps, and two public hearings following the release of draft voting district map(s); and
WHEREAS, at a special meeting of the City Council of the City of Glendora on the 13th day of July, 2017, the City Council adopted Resolution No. 2017-32 that initiated the process of establishing a by-district election system; and
WHEREAS, at special meetings of the City Council of the City of Glendora held on the 31st day of July, 2017 and the 2nd day of August, 2017, respectively, pursuant to California Elections Code Section 10010(a)(l), the City Council held public hearings where the public was invited to provide input regarding the composition of the City's voting districts before any draft maps were drawn, and the City Council of the City of Glendora considered and discussed the same; and
WHEREAS, at the special meeting of the City Council of the City of Glendora held on the 29th day of August, 2017, pursuant to California Elections Code Section 10010(a)(2), the City Council held a public hearing where the public was invited to provide input regarding the content of the draft maps that had been released at least seven (7) days before the meeting, and the City Council of the City of Glendora considered and discussed the same, and gave direction to staff regarding which maps were preferred and which the Council desired to be further refined based upon topography, geography, cohesiveness, contiguity, integrity, compactness of territory, and community of interests. At said public hearing, the City Council adopted a motion by Councilmember Davis and seconded by Councilmember Allowos directing the staff to utilize the draft maps drawn by Councilmembers Thompson and Allowos as a template and to further refine said maps in order to attempt to draw districts that include Arrow Highway, Route 66 and Foothill Blvd., decrease the population deviation, maintain the integrity of the Latino voting population in compliance with applicable legal authority, make the districts more contiguous, and increase the connectivity of the districts; and
WHEREAS, at the regular meeting of the City Council of the City of Glendora held on the 26th day of September, 2017, the City Council held a public hearing on the proposal to establish district boundaries, received additional public input, and directed staff to include the voting district map attached hereto as Exhibit A and incorporated herein by reference into the draft Ordinance for future consideration; and
WHEREAS, at the regular meeting of the City Council of the City of Glendora held on the 26th day of September, 2017, the City Council held a final public hearing on the proposal to establish district boundaries, received additional public input, formally selected the voting district map, as set forth in this Ordinance, which was introduced for a first reading at the same regular meeting of the City Council of the City of Glendora, but in a separate public hearing; and
WHEREAS, throughout the foregoing process, the City engaged in a significant amount of public outreach and engagement required by California Elections Code Section 10010; and
WHEREAS, the purpose of this Ordinance is to enact, pursuant to California Government Code Section 34886, an ordinance providing for the election of members of the City Council of the City of Glendora by-district in five single-member districts as reflected in Attachment 1 to this Ordinance, in furtherance of the purposes of the California Voting Rights Act of 2001 (Chapter 1.5 (commencing with Section 14025) of Division 14 of the Elections Code) and to implement the guarantees of Section 7 of Article I and of Section of Article II of the California Constitution.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENORA, CALIFORNIA, DOES HEREBY ORDAIN AS FOLLOWS:
SECTION 1. The foregoing recitals are true and correct.
SECTION 2. New Sections 2.04.070, 2.04.080, 2.04.090 and 2.04.100 of the Glendora Municipal Code are hereby added to read as follows:

- "2.04.070 By-District Electoral System. Pursuant to California Government Code Section 34886, as it may be amended, members of the City Council shall be elected on a by-district basis from five (5) single-member Council Districts. The City's by-district electoral system shall be conducted in accordance with California Government Code Section 34871, as it may be amended.
2.04.080 Establishment of City Council Electoral Districts. A. Pursuant to Section 2.04.070 of this Chapter, members of the City Council shall be elected on a by-district basis, as that term is defined in California Government Code Section 34871, as it may be amended, from the five Council Districts described as follows, which shall continue in effect until they are amended or repealed in accordance with law:
1. Council District 1 shall comprise all that portion of the City reflected on Attachment 1.
2. Council District 2 shall comprise all that portion of the City reflected on Attachment 1.
3. Council District 3 shall comprise all that portion of the City reflected on Attachment 1.
4. Council District 4 shall comprise all that portion of the City reflected on Attachment 1.
5. Council District 5 shall comprise all that portion of the City reflected on Attachment 1.

A map showing the districts described in this Ordinance is attached hereto as Attachment 1 and incorporated herein by reference.

B. Members of the City Council shall be elected in the electoral districts established by this Section and subsequently reapportioned pursuant to applicable state and federal law.

C. The member of the City Council elected to represent the City must reside in that district and be a registered voter in that district, and any candidate for City Council must live in, and be a registered voter in, the district in which he or she seeks election at the time nomination papers are issued, pursuant to California Government Code section 34882 as it may be amended, and Elections Code section 10227 as it may be amended. Termination of residency in a district by a member of the City Council shall create an immediate vacancy for that Council district unless a substitute residence within the district is established within thirty (30) days after the termination of residency.

D. Notwithstanding any other provision of this Section, and consistent with the requirements of California Government Code Section 36512, the members of the City Council in office at the time the Ordinance codified in this Chapter takes effect shall continue in office until the expiration of the full term to which he or she was elected and until his or her successor is qualified. At the end of the term of each member of the City Council, that member of the City Council's successor shall be elected on a by-district basis in the districts established in this Section and as provided in Section 2.04.090 of this Chapter.

2.04.090 Commencement of District Elections. Commencing with the general municipal election in March of 2019 and thereafter, the voters in Districts 2, 3and 5 shall elect Members of the City Council by district for full four (4) year terms. At the general municipal election in 2021 and thereafter, the voters in Districts 1 and 4 shall elect Members of the City Council by district for full four (4) year terms.

2.04.100 Adjustment of Boundaries. Pursuant to Elections Code Section 21601, as it may be amended, the City Council shall adjust the boundaries of any or all of the districts following each decennial federal census. Using the census as a basis, the City Council shall adjust the boundaries so that the districts shall be as nearly equal in population as practicable and in compliance with all applicable provisions of law. Any adjustment of district boundaries shall be made by ordinance adopted by the City Council before the first day of November of the year following the year in which each decennial federal census is taken. Prior to the public hearing approving the adjustment of the district boundaries, the City Council shall hold a public hearing on the proposed district boundaries as required by Election Code Section 21607 as it may be amended.

At the time of any annexation of territory to the City, the City Council shall designate, by resolution adopted by a vote of at least a majority of the City Council, the contiguous district to which the annexed territory shall be a part and shall amend the district boundaries if necessary in accordance with Election Code section 21603, as it may be amended.

SECTION 3. If necessary to facilitate the implementation of this Ordinance, the City Clerk is authorized to make technical adjustments to the district boundaries that do not substantively affect the populations in the districts, the eligibility of candidates, or the residence of elected officials within any district. The City Clerk shall consult with the City Manager and City Attorney concerning any technical adjustments deemed necessary and shall advise the City Council of any such adjustments required in the implementation of the districts.

SECTION 4. To the extent the terms and provisions of this Ordinance may be inconsistent or in conflict with the terms or conditions of any prior City ordinance, motion, resolution, rule or regulation governing the same subject, the terms of this Ordinance shall prevail with respect to the subject matter thereof.

SECTION 5. In interpreting this Ordinance or resolving any ambiguity, this Ordinance shall be interpreted in a manner that effectively accomplishes its stated purposes.

SECTION 6. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, then such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council of the City of Glendora hereby declares the Council would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that anyone or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 7. The Mayor shall sign this Ordinance and the City Clerk shall attest and certify to the passage and adoption thereof and cause same to be published at least once in the Glendora Press, a weekly newspaper of general circulation, published in the City of Glendora, which newspaper is hereby designated for that purpose; and thereupon, and thirty (30) days after its passage, this ordinance shall take effect and be in force.
