At this meeting, the City Council will receive public comment on the draft One-Year Action Plan (2018-2019) that will be submitted to the U.S. Department of Housing and Urban Development (HUD).

BACKGROUND

On May 6, 2015, the City adopted a Five-Year Consolidated Plan as part of the City's grant application to HUD. The plan established a framework of housing, community and economic development priorities over the next five years. The One-Year Action Plan then allocates Community Development Block Grant (CDBG) and Home Investment Partnerships (HOME) program funding that the City receives for specific programs and projects. These programs and projects are required to primarily benefit low- and moderate-income residents for a given year. This Action Plan will appropriate CDBG and HOME funds for 2018-2019 fiscal year, which the City anticipates to be approximately nine hundred twenty thousand dollars.
