- 1. Environmental Impact Report (EIR): To certify the EIR as adequately prepared in accordance with California Environmental Quality Act (CEQA) and to adopt required findings under CEQA and the Mitigation Monitoring and Reporting Program for General Plan Amendment (GPA) 19-004, Zone Change (ZCH) 19-004, Specific Plan 19-001, Vesting Tentative Tract Map 82874, and Site Plan Review (SPR) 19-023 for the proposed Covina Bowl Specific Plan Project. The project site is approximately 7.5-acres and generally located at 1118 W. San Bernardino Road, 1060 W. San Bernardino Road, 1103 W. Badillo Street, 1085 W. Badillo Street, and 1111 W. Badillo Street (APNs 8434-017-007, 8434-018-020, 8434-017-008, 8434-018-021, and 8434-017-009).
2. General Plan Amendment (GPA) 19-004: To amend the Covina General Plan Land Use Map changing the land use designations from General Commercial (GC) and High Density Residential (HDR) designations to Specific Plan (SP).
3. Zone Change (ZCH) 19-004: To amend the Official Zoning Map changing the zoning designation for a 7.5-acre project site from the existing Regional or Community Shopping center (C-3A) and Multiple Family (RD-1500) zoning districts to the "Covina Bowl Specific Plan (CBSP)" Planning Areas:
- Planning Area 1: CBSP Commercial/Office. The Covina Bowl building would be adaptively reused to provide approximately 12,000 square feet of commercial/office space that would be utilized for administrative offices, retail, coffee shop/bakery, and other uses commonly found in neighborhood commercial zones. Adaptive reuse of the Covina Bowl building would include demolition of the rear (west) mass that previously contained the bowling lanes, removal of the south addition, portions of the northern part, and restoration of the remaining building.
- Planning Area 2: CBSP Residential. The proposed development within Planning Area 2 consists of 132 for sale multi-family residential units that would be located within 16 three-story buildings. The proposed residential units would include one through four-bedroom units. In addition, the proposed development would provide approximately 5,026 square feet of common open space and recreational area.
- Planning Area 3: CBSP Mixed-Use. There is no specific development proposed for Planning Area 3. However, the Specific Plan includes buildout of the 0.35-acre area by removing the existing office space and development of either 4,175 square-feet of retail space or 11 multi-family residential units that would be accessed from Badillo Street.
- Planning Area 4: CBSP Mixed-Use. There is no specific development proposed for Planning Area 4. However, the Specific Plan includes buildout of the 1.71-acre area by removing the existing 31 apartment units, restaurant, and associated site improvements and development of either 37,244 square feet of retail space or 52 multi-family residential units.
4. Covina Bowl Specific Plan (SP) 19-001: To establish the "Covina Bowl Specific Plan (CBSP)" with 0.96 acres designated for "CBSP Commercial/Office Planning Area 1", 4.54 acres designated for "CBSP Residential Planning Area 2", 0.35 acres designated for "CBSP Mixed-Use Planning Area 3," and 1.71 acres designated for "CBSP Mixed-Use Planning Area 4."
5. Vesting Tentative Tract Map (TTM) 82874: To subdivide the 7.5-acre project site into 132 for-sale multi-family residential units within 16 three-story buildings in Planning Area 2, and the adaptive reuse of the Covina Bowl building for 12,000 square feet of commercial / office space within Planning Area 1, located at 1060 W. San Bernardino Road, 1085 W. Badillo Street, and 1111 W. Badillo Street (APNs, 8434-018-020, 8434-018-021, and 8434-017-009).
6. Site Plan Review (SPR) 19-023: A Site Plan Review for the development of 132-unit for-sale multi-family residential units within 16 three-story buildings in Planning Area 2, and the adaptive reuse of the Covina Bowl building for 12,000 square feet of commercial / office space within Planning Areas 1.

(LEGAL DESCRIPTION ON FILE IN THE PLANNING DIVISION)

Project Location: The project site is bounded by N Rimsdale Avenue to the east, W San Bernardino Road to the north, and W Badillo Street to the south and includes five parcels located at: 1118 W San Bernardino Road (APN 8434-017-007), 1060 W San Bernardino Road (APN 8434-018-020), 1103 W Badillo Street (APN 8434-017-008), 1085 W Badillo Street (APN 8434-018-021), and 1111 W Badillo Street (APN 8434-017-009).

Project Description: The proposed Specific Plan would divide the Project site into four Planning Areas and would permit a mixed-use development that includes adaptive reuse of the Covina Bowl building to provide 12,000 square feet commercial/office uses within Planning Area 1, and development of 132 for sale multi-family residential units within 16 three-story buildings in Planning Area 2. The Specific Plan would also allow for future mixed-use development within Planning Areas 3 & 4.

Given the multiphase nature of the proposed Project and the permitting, planning and development actions that are related both geographically and as logical parts in the chain of contemplated actions to implement the proposed Project, this document has been prepared as a Program EIR for the overall Covina Bowl Specific Plan, pursuant to Section 15168 of the CEQA Guidelines, and as a Project EIR for the pending development project that is a component of the overall proposed Project, pursuant to Section 15161 of the CEQA Guidelines.

Environmental Impact Report (EIR): The EIR identifies that the proposed project would result in no impact or less than significant impacts in the following environmental impact categories: aesthetics, energy, geology and soils, greenhouse gas emissions, hazards and hazardous materials, hydrology and water quality, land use and planning, public services, and parks and recreation. With the incorporation of mitigation measures identified in the Draft EIR, the potentially significant impacts of the proposed project in the following categories would be reduced below a level of significance: air quality, cultural resources, noise, transportation, and tribal cultural resources. No significant and unmitigable impacts have been identified in the Draft EIR. The Notice of Availability of the Draft EIR was published in the San Gabriel Valley Tribune on December 17, 2020 and the Draft EIR was released for a 45-day public comment period beginning on December 17, 2020 and ending on February 1, 2021. One comment letter was received during the Draft EIR review period and Responses to Comments were mailed 10 days prior to the Planning Commission considering the Project. The Draft EIR is available at City Hall, City Clerk Office or the Community Development Department, Planning Division, located at 125 E. College Street, Covina, CA, 91723, or at www.covicna.gov.

The City solicits any information and/or data that any citizen wishes to provide concerning these applications, and all interested citizens are invited to attend the public hearing. Any person may submit written comments to the Community Development Department, Planning Division, prior to or at the time of the hearing. If you challenge the decision on the proposed actions in court, you may be limited to raising only those issues you or someone else raised at the public hearing or in correspondence submitted prior to or during the hearing.

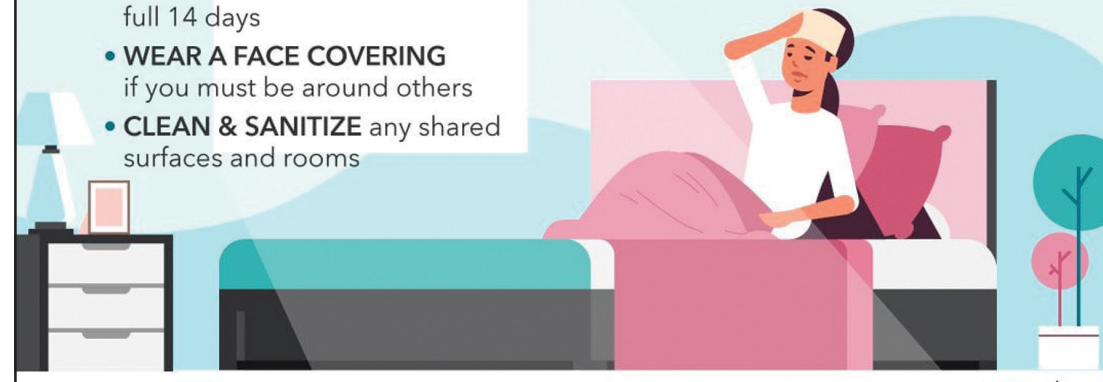
