IF YOU ARE A CREDITOR or a CONTINGENT CREDITOR OF THE DECEDENT, you must file your claim with the court and mail a copy to the personal representative appointed by the court within the later of either (1) four months from the date of first issuance of letters to a general personal representative, as defined in section 58(b) of the California Probate Code, or (2) 60 days from the date of mailing or personal delivery to you of a notice under section 9052 of the California Probate Code.

Other California statutes and legal authority may affect your rights as a creditor. You may want to consult with an attorney knowledgeable in California law.

You may examine the file kept by the court. If you are a person interested in the estate, you may file with the court a Request for Special Notice (form DE-154) of the filing of an inventory and appraisal of the estate assets or of any petition or account as provided in Probate Code section 1250. A Request for Special Notice form is available from the court clerk.

Notice of Exemption (NOE):

In accordance with CEQA, the City of Covina has completed an Initial Study to determine whether the project may have a significant effect on the environment. The Initial Study, which reflects the independent judgment of the City, concludes that the project will not have a significant effect on the environment. The City has therefore prepared a Notice of Exemption (NOE), to be considered by the Planning Commission and City Council. Pursuant to Section 15072 of the CEQA guidelines, the project site is not on any of the lists enumerated under Section 65962.5 of the Government Code.

The City of Covina, as Lead Agency, will utilize this document as evidence that the proposed Project qualifies for an exemption from further California Environmental Quality Act (CEQA) review pursuant to CEQA Guidelines Section 15182, Projects Pursuant to a Specific Plan. This memorandum analyzes the proposed VitaPakt 707 N. Barranca Ave Project to determine its eligibility to be exempt from further CEQA review pursuant to its consistency with the adopted Specific Plan and certified Environmental Impact Report (EIR). Development projects that are undertaken pursuant to a specific plan for which an EIR was previously prepared are exempt from further CEQA review if the projects are in conformity with that specific plan and the conditions described in CEQA Guidelines section 15162 (relating to the preparation of a subsequent EIR) are not present. (Gov. Code, § 65457, subd. (a); Guidelines, § 15182, subd. (c). § 15162, subd. (a)).

The City of Covina adopted the Update to the Covina Town Center Specific Plan ("CTCSP"), amended the existing 2004 Covina Town Center Specific Plan, and certified the CTCSP EIR ("CTCSP EIR" or "Certified EIR") on November 19, 2019. Individual development projects that implement the CTCSP are eligible for the CEQA Guidelines Section 15182 exemption if none of the conditions described in CEQA Guidelines Section 15162 calling for preparation of a subsequent EIR have occurred.

The proposed Project would redevelop an approximately 5.9-acre site located in the north-eastern portion of the CTCSP area, which is currently vacant, but was previously developed with the VitaPakt citrus processing facility. The Project would construct 24 three-story residential buildings with up to 151 townhome residences that would be consistent with the High Density Residential/Transit Oriented Development zoning of the Project site. The proposed Project is consistent with the CTCSP, and it therefore qualifies for a CEQA exemption pursuant to CEQA Guidelines Section 15182. Based on the proposed Project description and knowledge of the Project site, and findings of the CTCSP EIR, the City has concluded that the proposed Project would not result in any new or increased impacts not previously disclosed in the CTCSP EIR. For these reasons, the City has concluded that the Project qualifies for the exemption to CEQA review set forth in Government Code Section 65457 and CEQA Guidelines Section 15182.

The CTCSP EIR serves as the previous CEQA document considered in this CEQA Analysis. The document is hereby incorporated by reference and is available for review the City of Covina Planning Division at 125 E. College Street, Covina, CA 91701

The City solicits any information and/or data that any citizen wishes to provide concerning the proposed project, and all interested citizens are invited to attend the public hearing.
