CITY OF COVINA NOTICE OF PUBLIC HEARINGS

NOTICE IS HEREBY GIVEN that the City Council of the City of Covina will conduct a PUBLIC HEARING in the City Hall Council Chambers, 125 East College Street, Covina, on Tuesday, January 18 2022 at 7:30 p.m., to consider the following applications:

- 1. A General Plan Amendment (GPA) 21-1 to change the land use designation from "General Commercial" to "High Density Residential," a Covina Forward Specific Plan (CFSP) Amendment 21-1 to change the zoning from "Institutional" to "RD Multi-Family Residential," a Tentative Tract Map (TTM) 83343, and a Site Plan Review (SPR) 21-87, to allow the construction of five (5) 3-story townhouse buildings, totaling 38 units with 2-car attached garages on approximately 1.5 acres of land, located at 155 E. Covina Boulevard - APN: 8406-019-097.

Planning Commission Recommendation: On December 14, 2021, the Planning Commission of the City of Covina conducted a duly noticed public hearing to consider the above described project. The Planning Commission concluded said hearing on December 14, 2021 and adopted Planning Commission Resolution No. 2021-026 PC, by a 5-0 vote, recommending that the City Council of the City of Covina approve General Plan Amendment (GPA) 21-1, Covina Forward Specific Plan Amendment 21-1, Tentative Tract Map 83343, and Site Plan Review (SPR) 21-87

Pursuant to and in accordance with the provisions of the California Environmental Quality Act (CEQA) Guidelines, the City has analyzed the proposed project and concluded that an Addendum to the adopted Environmental Impact Report (EIR - SCH No. 2016051053) could be prepared. State CEQA Guidelines (Sections 15162 and 15164) provide that an Addendum to an adopted EIR may be prepared if none of the conditions triggering a subsequent EIR are present. The City has conducted a full analysis of the proposed project as compared to the original Project and determine whether implementation of the proposed project would result in any new significant environmental impacts not identified in the certified EIR. This addendum also evaluates whether mitigation measures or alternatives previously found infeasible would become feasible due to changes that have occurred since certification of the EIR. The proposed project does not change the nature of the environmental impacts associated with the original Project, which remain the same levels as described in the adopted 2016 EIR and none of CEQA Guideline 15162's criteria is triggered. Thus, a subsequent or supplemental environmental document is NOT required to be prepared. In particular, there have been no:

- Substantial changes proposed for the Project that will require major revision of a previous Negative Declaration due to the involvement of new, significant environmental effects or a substantial increase in the severity of previous identified effects;
- Substantial changes with respect to the circumstances under which the Project is undertaken, requiring major revision to a previous EIR due to the involvement of new significant environmental effects or a substantial increase in the severity of previously identified ones; and
- New information of substantial importance that was not known or could not have been known without the exercise of reasonable diligence at the time the previous EIR was adopted that shows any of the following:
o The Project will have one or more significant effects not discussed in the previous EIR;
- o Significant effects previously examined will be substantially more severe than disclosed in the previous EIR ;
- o Mitigation measures or alternatives previously found not to be feasible would in fact be feasible and would substantially reduce one or more significant effects of the Project, but the Project proponents decline to adopt them.

The Planning Commission will consider the aforementioned Amendments and make a recommendation to the City Council for a final decision. The public hearing before the City Council will be scheduled and noticed for a later date.

The City of Covina currently elects its City Councilmembers through an "at-large" election system in which each Councilmember can reside anywhere in the City and is elected by the voters of the entire City to provide city-wide representation. On October 21, 2021, the City Council adopted a resolution declaring its intent to transition from at-large to district-based Councilmember elections. In a district-based election system, the City would be divided into smaller geographic districts and voters residing in each district would elect a single member to represent them in the City Council.

This will be the fifth (5) public hearing concerning a transition from at-large Council elections to district-based Council elections as set forth in Elections Code Section 10010. The purpose of this hearing is to adopt the ordinance establishing district-based elections and approving district boundaries for the City Council districts and the sequence of elections for City Councilmembers.
