ORDINANCE NO. 2013 AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GLENDORA, CALIFORNIA, AMENDING THE GLENDORA MUNICIPAL CODE SECTION 2.04.060 AND 2.18.010 REMOVING THE INVESTMENT ADVISORY COMMITTEE FROM EACH SECTION THE CITY COUNCIL City of Glendora, California

WHEREAS, the City of Glendora is a general law city; and WHEREAS, California Government Code Section 37100 and California Constitution Article II, Section 7 provides that a legislative body may pass Ordinances not in conflict with the Constitution and the laws of the State or the United States; and WHEREAS, by minute motion on February 27, 1996 and on April 23, 1996, the Glendora City Council did establish the procedures and guidelines for an Investment Advisory Committee to provide input to the City Treasurer and critically review the City's and the Community Redevelopment Agency's investment portfolio and associated reports; and WHEREAS on June 12, 2001, the Glendora City Council adopted Resolution No. 01-42 modifying the composition of the City/CRA Investment Advisory Committee; and WHEREAS, the City of Glendora municipal code section Title 2 ADMINISTRATION AND PERSONNEL, section 2.04.060 Application and Section 2.18.010 Commission and Committee Defined include references to "investment advisory committee"; and WHEREAS, the City of Glendora desires to decommission the Investment Advisory Committee; and WHEREAS, the City's current practices and procedures, combined with the State regulations on investments that the City may participate in, renders the requirements of having an Investment Advisory Committee moot; and WHEREAS, the City has been unable to attract candidates to sit on the Investment Advisory Committee; and WHEREAS, on February 28, 2017, the City Council directed staff to bring forward a resolution for the City Council to consider decommissioning the Investment Advisory Committee; and WHEREAS, changes to the ordinance are also necessary. NOW, THEREFORE, the City Council of the City of Glendora, California, does hereby ordain as follows: Section 1. Chapter 2.04.060 of the Glendora Municipal Code entitled "Application" is hereby amended to read as follows: "2.04.060 Application. The provisions of this code apply to the planning commission, community services commission and to all other commissions and/or citizen advisory boards whose members are appointed by the city council, or by the mayor with consent of the city council. Notwithstanding the fixed terms of office specified in this code, members of the commissions and citizen advisory boards do and shall serve at the pleasure of the city council. Any commissioner and citizen advisory board member may be removed at any time from the commission and/or citizen advisory board by a majority vote of the council. Notwithstanding the expiration date of a term of a member of a commission or citizen advisory board, each commissioner/citizen advisory board member, with or without cause, may be removed as a member of the commission/citizen advisory board by order of the city council."
