SUMMARY OF APPROVED ORDINANCE

NOTICE IS HEREBY GIVEN THAT at their meeting held June 27, 2017, the Glendora City Council unanimously voted to adopt Ordinance No. 2017, which amends several sections of Glendora Municipal Code Title 21 (Zoning). The ordinance enacts the following regulations and policies: 1) Allows beauty spas by right as a permitted use, and requires a Conditional Use permit when massage services are provided; 2) Allows permanent cosmetics services in conjunction with a beauty spa; 3) Modifies parking regulations for restaurants and medical uses; and, 4) Amends the list of project types requiring a development plan review permit.

Said ordinance will become effective 30 days after adoption.
