THE CITY COUNCIL OF THE CITY OF GLENORA DOES HEREBY RESOLVE AS FOLLOWS:

WHEREAS, by Resolution CC 2017-13, the City Council initiated proceedings to levy an assessment for Fiscal Year 2017-18 in connection with City of Glendora Landscape Maintenance District No. 1 (the "District") (formerly known as "City of Glendora Landscaping & Lighting District No. 1") pursuant to the Landscaping and Lighting Act of 1972 (California Streets & Highways Code Section 22500 et seq.) (the "Assessment Law"); and

WHEREAS, by prior resolution, the City Council approved a preliminary report of the City Engineer entitled "Engineer's Annual Levy Report, City of Glendora Landscape Maintenance District No 1 - Fiscal Year 2017-18 Assessment" and dated May 2017, (the "Report"), which Report is on file in the office of the City Clerk and available for public inspection; and

WHEREAS, the City Council desires to move forward with proceedings to levy the Fiscal Year 2017-18 assessment in connection with the District; and

WHEREAS, Section 22609 of the landscaping and Lighting Act of 1972 authorizes the detachment of territory within Glendora Landscape Maintenance District No. 1.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENORA, CALIFORNIA DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. The foregoing recitals are true and correct.

Section 2. The City Council declares its intention to levy and collect an assessment for Fiscal Year 2017-13 in connection with the District.

Section 3. The purpose of the District is to finance the landscape maintenance of certain areas in the City and to cover the incidental expenses of the assessment district.

Section 4. The proposed assessments and landscape improvements are as detailed in the preliminary Engineer's report for Glendora Landscape Maintenance District No. 1.

Section 5. The proposed territory to be detached is detailed in the preliminary Engineer's Report for Glendora Landscape Maintenance District No. 1 for Fiscal Year 2017/2018.

Section 6. The detachment of this territory will have no fiscal impact on the assessments for the remaining zones and parcel within Glendora Landscape Maintenance District No. 1 for Fiscal Year 2017/2018.

Section 7. The distinctive designation of the District is "City of Glendora Landscape Maintenance District No. 1" and the boundaries of the District may be generally described as including the following zones within the City:

Section 13. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.

Section 14. The City Clerk shall cause this Resolution to be published once at least ten (10) days prior to the date of the Hearing specified above in a newspaper of general circulation printed and published within the City of Glendora, and shall post a certified copy of the Resolution in established posting locations according to law.
