Azusa Pacific University Theater Department Presents New Works Play Festival, New Plays By Students

AZUSA - Azusa Pacific University (APU) Theatre department is pleased to present Four original one acts written by APU Students.

The New Works Festival creates an opportunity for the development of new plays by supporting aspiring playwrights. It is a series of one-act plays promoting new writing, directing, and performing talents. Each play has been developed through coursework, workshop readings, and production. Playwrights have collaborated with guest directors, guest designers, faculty, actors, and student dramaturgs throughout the process. Students will submit these one acts to compete in the prestigious Kennedy Center/American College Theater Festival.

According to Director, Dr. Rachel Tracie, "APU Theater's New Works Play Festival is a festival which presents new plays by APU students. The playwrights are able to develop their plays through the rehearsal process with a cast of actors and faculty directors and make revisions and edits. Even the performance is a part of the process, where the

playwrights will use the final production as another opportunity to refine their play after seeing it in performance. The audience becomes a vital part of the process - their reactions and engagement gives the playwright valuable information about what is working and what still needs to be refined.

We have four plays by student playwrights - each deals with different styles and subject matter, but all have at their core the idea of belonging and the ways in which individuals manipulate and shift their own identities to navigate through their circumstances and environment to find a sense of belonging." Dr Tracie will direct two of the one acts.

The one acts include, In Loving Memory written by student Natalie Perret, The Elephant in the Room by student Dylan Ruder, Verses from the Fray by student Hayden Royster and Painted Blind by student Anna Lund. Guest Director, Jeremy Lewis, will direct the other two one acts and has this to say about the Festival, "workshopping a new play is an important and necessary aspect of the developmental pro-

cess, and for many young playwrights it can be years before a theater is willing to provide them that opportunity. The New Works Festival here at APU is an amazing opportunity for the students and as a director, I am honored to help make each new play a reality."

Arcadia High School Recognized as One of Best Public High Schools in California

ARCADIA - With tax season underway, everyone is busy crunching the numbers. Niche, an influential school and neighborhood review website, has been busy calculating data of its own. According to Niche's 2017 Best Public High Schools in California, Arcadia High School is among the top 2 percent of the best public high schools in the state.

With more than 1,300 public high schools in California, landing the number 30 spot on Niche's list is no small feat. Arcadia High has moved up five spots from its number 35 ranking last year to 30 on this year's list.

The Constitution team recently qualified for its third consecutive trip to compete in Washington D.C. at the national championships.

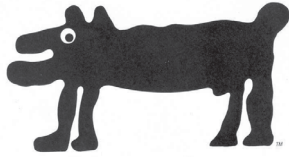

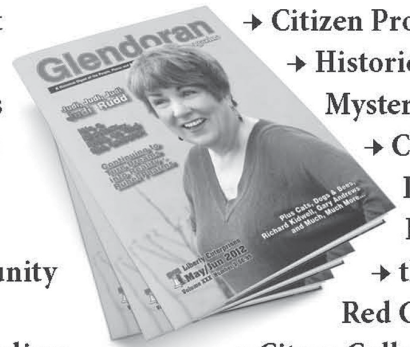

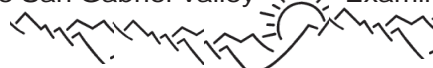
