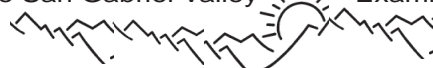

**PUBLIC HEARING MEETING LOCATION AND DATE**

The City of Glendora is requesting public input on its Community Development Block Grant (CDBG) Program at 7:00 P.M., at its April 24, 2018 City Council meeting. The draft Consolidated Plan, Annual Action Plan, and Analysis of Impediments documents are available between March 22, 2018 and April 23, 2018 for a 30-day review.

In compliance with the American with Disabilities Act, if you need special assistance to participate in the meeting, please contact the City of Glendora's City Clerk's Office at (626) 914-8210. Notification 48 hours prior to the April 24, 2018 City Council meeting will enable the City to make reasonable arrangements to ensure accessibility to the meeting.

**BACKGROUND**

**Consolidated Plan:** Every five years, the CDBG program requires that the City adopt a "Consolidated Plan," which establishes the goals and objectives of the City's CDBG program. During the development of this 2018-2023 Consolidated Plan, which forms the basis for establishing objectives and outcomes in the Strategic Plan and five (5) subsequent Annual Action Plans, the following priority needs and objectives were established:

- 1. Infrastructure and Public Facilities:** Improve and expand infrastructure and public facilities that benefit low and moderate income neighborhoods and residents.
- 2. Economic and Human Development:** Provide for the economic development needs of low and moderate income persons and neighborhood target areas.
- 3. Fair Housing:** Promote fair and equal housing choice for all persons.
- 4. Administration and Planning:** Provide for administration and planning activities to carry out actions that address identified needs in the Consolidated Plan.

These established Priority Needs form the basis for allocating investments geographically within the City during the next five-year period and are a result of various community outreach efforts and consultation meetings developed under the Citizen Participation process.

**Annual Action Plan:** The Annual Action Plan is part of the Five-Year Consolidated Plan and serves as the City's application for funding from HUD. The City of Glendora anticipates an allocation of \$245,502 of CDBG funds for FY 2018-2019. As the Federal Budget has not been approved at this time and the City must meet certain statutory deadlines in submitting its annual Action Plan and allowing for citizen participation, staff has developed this allocation amount based on last year's allocation as follows:

**Final Funding Allocation and Adjustments:** As HUD announcement of final allocation may occur after the April 24, 2018 public hearing, the City recommends the following method of adjustments to the budget once the final allocation is announced:

- Fair Housing \$15,000 (no adjustment)
- General Administration Adjust to 20% of allocation inclusive of \$15,000 for Fair Housing
- Public Improvements (Library ADA Signage) \$6,500 (no adjustment)
- Business Assistance Program \$25,000 (no adjustment)
- Street Improvement Project Adjust to balance of allocation

**Analysis of Impediments (AI) to Fair Housing Choice:** The AI presents a demographic profile of Glendora, assesses the extent of housing needs of its residents, and evaluates the availability of a range of housing choices for all. Below is a brief summary of findings:

- Fair Housing Complaints:** The incidents of discrimination complaints have been limited in recent years; no complaints were found to have evidence to sustain the allegations in the last three years. Disability was identified as the most frequent basis of fair housing complaints filed with HRC, the State Department of Fair Employment and Housing (DFEH), and with HUD.
- Outreach and Education:** The number of fair housing complaints has continued to decline over the years, a sign of improved awareness.
- Lending Practice:** Discrepancies in lending patterns among various racial/ethnic groups have narrowed over the last few years. However, the incidence of subprime lending has increased for White, Hispanic, and Asian applicants.
- Real Estate Advertisements:** For-sale and for-rent listings were reviewed for discriminatory language. Both types of listings show strong preferences for families.

These findings suggest that continued outreach and education would ensure residents and housing providers are aware of their fair housing rights and responsibilities.
