Project Description – The general nature of work consists of furnishing all labor, material, equipment, services, and incidentals required for pavement construction improvements. The work includes removal and replacement of 2-inches of existing roadway and constructing asphalt concrete (AC) pavement sections. Concrete improvements include constructing cross-grutters, spandrels, curb ramps, and curb and gutter. Related work includes adjusting manholes and utility covers, traffic control, repainting traffic stripes and pavement markings, placing pavement markers and all appurtenant work.
