THE CITY OF BALDWIN PARK IS CURRENTLY ACCEPTING APPLICATIONS FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM FOR FISCAL YEAR 2019-2020. The City is seeking proposals from organizations with proven professional experience in public service activities.

The City expects to have approximately \$950,000 in FY 2019-2020 CDBG funding. Of this amount, 15% or approximately \$142,500 may be used for public service grants.
