College Street, Covina, California 91723-2199 up to **Tuesday 10:00 am on September 1st, 2020** at which time they will be publicly opened and read aloud. All Bids must be made on the form furnished by the City. Each Bid must be submitted in a sealed package addressed to the City Clerk with the Project name and Project number typed or clearly printed on the lower left corner of the package. Bids must remain valid and shall not be subject to withdrawal for sixty (60) calendar days ("Days") after the Bid opening date.

SCOPE OF WORK
The project consist of removal and replacement of approximate 12,000 SF PCC sidewalk, curb and gutter, driveway and other related work as described in the Plans, Specifications, and Contract Documents, by this reference, made a part hereof.

LIQUIDATED DAMAGES
The engineer's estimate for this project is \$150,000. The successful bidder shall have FORTY-FIVE (45) calendar days to complete the work. Liquidated damages shall be \$500.00 per working day.

OBTAINING BID DOCUMENTS
Bidders may obtain free copies of the Plans, Specifications and other Contract Documents online by visiting the City website. Potential Bidders may also obtain the Contract Documents for the Project at Covina City Hall, 125 E. College Street, Covina, California 91723-2199 for a non-refundable fee of \$60 per set, or \$65 per set if mailed. The City must receive payment before the Contract Documents will be provided.

Bidders shall supply the City Clerk with a facsimile number and email address to facilitate transmission of Addenda and other information related to these Contract Documents. REGISTRATION WITH THE DEPARTMENT OF INDUSTRIAL RELATIONS
SB 854 Requirements:
This project is subject to the requirements of SB 854. No prime contractor or subcontractor may be listed on a bid proposal for a public works project unless registered and qualified with the Department of Industrial Relations pursuant to Labor Code section 1725.5. Copies of those rates are on file with the Director of Public Works, and are available to any interested party upon request. The Contractor shall post a copy of the DIR's determination of the prevailing rate of per diem wages at each job site. This Project is subject to compliance monitoring and enforcement by the DIR.

BONDS
Each Bid must be accompanied by a cash deposit, cashier's check, certified check or Bidder's Bond issued by a Surety insurer, made payable to the City and in an amount not less than ten percent (10%) of the total Bid submitted. Personal or company checks are not acceptable. Upon Contract award, the Contractor shall provide faithful performance and payment Bonds, each in a sum equal to the Contract Price.
