THE CITY OF BALDWIN PARK IS CURRENTLY ACCEPTING APPLICATIONS FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM FOR FISCAL YEAR 2020-2021. The City is seeking proposals from organizations with proven professional experience in public service activities.
