College Street, Covina, California 91723-2199 up to Tuesday 10:00 am on April 6th, 2021 at which time they will be publicly opened and read aloud.

All Bids must be made on the form furnished by the City. Each Bid must be submitted in a sealed package addressed to the City Clerk with the Project name and Project number typed or clearly printed on the lower left corner of the package. Bids must remain valid and shall not be subject to withdrawal for sixty (60) calendar days ("Days") after the Bid opening date.

SCOPE OF WORK The project consists of the reconstruction of a parking lot, parking lights installation, landscape, miscellaneous concrete, grease interceptor, garbage enclosure, storm drain, water services and other related work as described in the Plans, Specifications, and Contract Documents, by this reference, made a part hereof.

LIQUIDATED DAMAGES The engineer's estimate for this project is \$985,000. The successful bidder shall have Ninety (90) calendar days to complete the work. Liquidated damages shall be \$500.00 per working day.

The City of Glendora is requesting public input on its Community Development Block Grant (CDBG) Program at 7:00 P.M., at its April 13, 2021 City Council meeting. The draft Annual Action Plan will be available on April 14, 2021 for a 30-day public review, ending May 24, 2021. A second public hearing will be held on May 25, 2021 to approve submittal of the Plan to the U.S. Department of Housing and Urban Development (HUD).

Notification 48 hours prior to the scheduled City Council meetings will enable the City to make reasonable arrangements to ensure accessibility to the meeting.

BACKGROUND

Consolidated Plan: Every five years, the CDBG program requires that the City adopt a "Consolidated Plan," which establishes the goals and objectives of the City's CDBG program. During the development of this 2018-2023 Consolidated Plan, which forms the basis for establishing objectives and outcomes in the Strategic Plan and five (5) subsequent Annual Action Plans, the following priority needs and objectives were established:

- 1. Infrastructure and Public Facilities: Improve and expand infrastructure and public facilities that benefit low- and moderate-income neighborhoods and residents.
2. Economic and Human Development: Provide for the economic development needs of low- and moderate-income persons and neighborhood target areas.
3. Fair Housing: Promote fair and equal housing choice for all persons.
4. Administration and Planning: Provide for administration and planning activities to carry out actions that address identified needs in the Consolidated Plan.

These established Priority Needs form the basis for allocating investments geographically within the City during the next five-year period and are a result of various community outreach efforts and consultation meetings developed under the Citizen Participation process.

Only eligible activities that receive a High priority level in the FY 2018-2023 Consolidated Plan will be funded during the five year period.

Annual Action Plan: The Annual Action Plan is part of the Five-Year Consolidated Plan and serves as the City's application for funding from HUD. The City of Glendora will receive an allocation of \$310,175 of CDBG funds for FY 2021-2022, as stated in the notice from HUD dated February 25, 2021.

In addition to the annual allocation, unspent funds are available from FY 2019-2020 in the amount of \$189,323. These unspent funds will be allocated to projects in FY 2021-2022. Combined with the anticipated allocation, a total of \$499,498 will be available in FY 2021-2022. Should there be any amendments to the dollar amount of funding available, staff will revise the budget either increasing or decreasing funding appropriated to the infrastructure improvements.

The CDBG funding may be allocated to the following types of eligible projects:

- 1. Acquisition: by purchase, long-term lease, and donation of real property for an eligible public purpose.
2. Disposition: of real property acquired under the CDBG Program.
3. Construction and Rehabilitation: of certain publicly owned facilities, such as (a) senior citizen centers; (b) parks and playgrounds; (c) community centers; (d) fire protection facilities and equipment; (e) sidewalks and street improvements; (f) water and sewer systems.
4. Rehabilitation of publicly and privately owned housing: for low- and moderate-income households.
5. Public Services: which are new or expanding, and directed toward meeting employment, crime prevention, childcare, drug abuse prevention, homeless assistance, or other community service needs.
6. Removal of Architectural Barriers: that restricts the mobility and accessibility of elderly or handicapped persons to publicly owned and privately-owned buildings, facilities, and improvements.
7. Special Economic Development Activities: that provide grants, loan guarantees and other forms of necessary or appropriate support to private "for profit" businesses to provide increasing employment opportunities and other public benefit.

While funding amounts are somewhat flexible, there are statutory limitations that restrict the amount of funding for Planning and Administration costs to not more than 20 percent of the annual grant allocation and limit public services to 15 percent of the annual grant allocation.

Based on the limited amount of resources available to the City, statutory restrictions, and the Priority Needs established, staff recommendations for the FY 2020-2021 CDBG One-Year Annual Action Plan are as follows:

AN ORDINANCE APPROVING A ZONE CHANGE FROM MULTI-FAMILY RESIDENTIAL (R-3) TO TOWN CENTER MIXED USE (RT66-TCMU) ON CERTAIN PROPERTY LOCATED AT 501 WEST ROUTE 66 AND 532 PARKER DRIVE, GLENDDORA, CALIFORNIA (PROJECT NUMBER: PLN19-0046); COMPLIANCE WITH CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA)

THE CITY COUNCIL

WHEREAS, 501 E. Route 66 Partners, LLC filed an application requesting approval to amend the Glendora General Plan Map as well as the zoning pursuant to the Route 66-Town Center Mixed Use (RT66-TCMU) zone; Development Plan Review to allow construction of eight three-story residential townhomes within two buildings and one single-story, 1,000 square-foot commercial office building; Tentative Tract Map to consolidate three parcels and subdivide the 0.72-acre site to create a condominium development with eight residential units and one commercial building; on certain property located at 501 West Route 66 and 532 Parker Drive, Glendora, California (Project No. PLN19-0046); and

WHEREAS, Pursuant to Glendora Municipal Code §21.10.320C: "The Town Center Mixed Use district is intended to provide for a complementary mix of land uses and development types that are compatible with and reinforce pedestrian activity and transit utilization. WHEREAS, the environmental review for the project's General Plan Amendment, Zone Change, DPR, and Tentative Tract Map was processed in accordance with the requirements of the California Environmental Quality Act (CEQA) and the Initial Study and Mitigated Negative Declaration (IS/MND) was available for public review from November 23, 2020 to December 23, 2020; and

WHEREAS, a public hearing was held by the Planning Commission of the City of Glendora on February 2, 2021, after due notice was given as required by law, at which time oral and documentary evidence was introduced along with the written analysis of the Planning Division of the City of Glendora, and the Planning Commission recommended approval of Project No. PLN19-0046 to the City Council; and

WHEREAS, the City Council held a public hearing on March 9, 2021, after due notice was given as required by law, at which time oral and documentary evidence was introduced along with the recommendation of the Planning Commission of the City of Glendora.

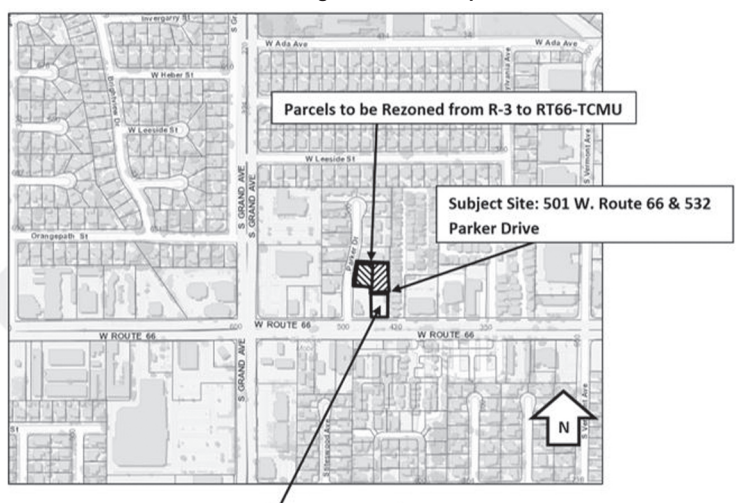
NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENDDORA, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. The above recitals are true and correct and are incorporated by reference.
SECTION 2. The City Council based on the evidence in the record inclusive of the staff report, and written/oral testimony, hereby approves a zone change designation from Multi-Family Residential (R-3) to Route 66-Town Center Mixed Use (RT66-TCMU) on certain properties at 501 West Route 66 and 532 Parker Drive, Glendora, California (Project No. PLN19-0046) and shown on Exhibit A:

SECTION 3. Findings. The City Council finds that public necessity, general welfare, good planning practices, public interest, and convenience warrant approval of the General Plan Amendment.

- a. General Plan. The City Council finds that the project is consistent with the General Plan goals and policies, any operative plan, or adopted policy.
b. Zoning. The project does not affect the implementation of the General Plan with respect to surrounding properties. The proposed project is consistent with the purpose of the zoning ordinance to promote and protect the public's health, safety, peace, comfort, convenience and general welfare.
c. CEQA. The potential impacts of the proposed project have been assessed as required by CEQA as noted above, and have been determined not to be detrimental to the public health, safety, or welfare, and will not have a significant impact on the environment.

As such, approval of these items would be in the best interest of the City.
SECTION 4. Consistent with the requirements of the California Environmental Quality Act ("CEQA"), the potential environmental impacts of this Zone Change were assessed in the mitigated negative declaration recommended for adoption by the Planning Commission on February 2, 2021. More specifically, the Planning Commission recommended to the City Council adoption of a mitigated negative declaration and mitigation monitoring and reporting program for this Project, all of which is approved concurrently herewith.

SECTION 5. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unenforceable by a court of competent jurisdiction, the remaining portions of this Ordinance shall nonetheless remain in full force and effect. The people of the City of Glendora hereby declare that they would have adopted each section, subsection, sentence, clause, phrase, or portion of this Ordinance, irrespective of the fact that any one or more sections, subsections, sentences, clauses, phrases, or portions of this Ordinance be declared invalid or unenforceable.

SECTION 6. The Mayor shall sign this Ordinance and the City Clerk shall attest and certify to the passage and adoption thereof and cause same to be published at least once in the San Gabriel Valley Examiner, a weekly newspaper of general circulation, published in the City of Glendora, which newspaper is hereby designated for that purpose; and thereupon, and thirty (30) days after its passage, this ordinance shall take effect and be in force.
