NOTICE IS HEREBY GIVEN, that the City Council of the City of Covina will conduct a PUBLIC HEARING in the City Hall Council Chamber, 125 East College Street, Covina, on **Tuesday, August 17, 2021, at 7:30 p.m.** to consider resolutions approving Community Facilities District No. 2007-1 (Public Services) Annexation No. 29, and authorizing submittal of levy of special taxes to the qualified electors.

On July 6, 2021, the City Council adopted Resolution CC 2021-82 ("Resolution of Intention") declaring its intention to annex into Community Facilities District No. 2007-1 (Public Services) (the "CFD") certain territory referred to herein as Annexation No. 29. The territory of Annexation No. 29 is specifically described in that certain Annexation Map, attached as Exhibit "A" to the Resolution of Intention. The types of public services to be provided and financed by the CFD are (i) police services, (ii) fire protection and suppression services, (iii) paramedic services and (iv) park maintenance. Except where funds are otherwise available, a special tax sufficient to pay for the above services will be annually levied and collected upon all non-exempt property within the CFD and Annexation No. 29 in the same manner as ordinary *ad valorem* property taxes, as more particularly set forth in that certain First Amended Rate and Method of Apportionment, attached as Exhibit "B" to the Resolution of Intention. Reference is made to the Resolution of Intention on file in the office of the City Clerk for details about the extent of the CFD, the Services, the Special Tax, the protest proceeding and the proposed voting procedure. A copy of the Resolution of Intention and the associated staff report are on file and available for public inspection in the office of the City Clerk, located at 125 E. College Street, Covina, CA 91723.

At the hearing, all interested persons for or against the annexation of Annexation No. 29 to the CFD, the extent of the annexation, the furnishing of specified types of services, or the levying of special taxes within Annexation No. 29 will be heard. If a majority protest against Annexation No. 29 into the CFD is filed, as determined in accordance with Section 53339.6 of the Act, no further proceedings for Annexation No. 29 or to authorize the Special Tax upon the certain property proposed for annexation shall be taken for a period of one year from the date of the decision of the City Council. If the majority protests are only against the furnishing of a specified type or types of services within the proposed annexation area of the CFD or portions of the Special Tax within Annexation No. 29, those services or that portion of the Special Tax shall be eliminated. The hearing and protest procedures with respect to Annexation No. 29 are more particularly set forth in the Resolution of Intention.

If the City Council determines to establish the CFD and proposes to levy the Special Tax, the City Council will submit the levy of the Special Tax to the qualified electors of the CFD. The vote will be by the landowners of the CFD with each landowner having one vote for each acre or portion of an acre of land owned within the CFD. The election will be conducted by the City Clerk in conformance with the provisions of Section 53326 of the Act and pursuant to the provisions of the California Elections Code, insofar as they may be applicable. The election will be conducted as a mail ballot election.

Copies of the public reports and resolutions concerning Annexation No. 29 to the CFD will be available for public inspection in the offices of the Covina City Clerk during regular counter hours.
