### Mitigated Negative Declaration (MND):

In accordance with CEQA, the City of Covina has completed an Initial Study to determine whether the project may have a significant effect on the environment. The Initial Study, which reflects the independent judgment of the City, concludes that the project will not have a significant effect on the environment. The City has therefore prepared a Mitigated Negative Declaration (MND), to be considered by the Planning Commission and City Council. Pursuant to Section 15072 of the CEQA guidelines, the project site is not on any of the lists enumerated under Section 65962.5 of the Government Code.

The MND identifies that the proposed project would result in no impact or less than significant impacts in the following environmental impact categories: aesthetics, agricultural and forestry resources, air quality, geology and soils, greenhouse gas emissions, hazards and hazardous materials, hydrology and water quality, land use and planning, mineral resources, population and housing, recreation, transportation and traffic, tribal cultural resources, and utilities and service systems. With the incorporation of mitigation measures identified in the MND, the potentially significant impacts of the proposed project in the following categories would be reduced below a level of significance: biological resources, cultural resources, and noise. No significant and unmitigated impacts have been identified in the MND. The Notice of Intent to adopt the MND was published in the San Gabriel Valley Examiner on September 3, 2020, and the MND was released for a 20-day public comment period beginning on September 3, 2020 and ending on September 23, 2020. There was no comment letter received for the draft MND. The Final MND has been completed in accordance with the requirements of the State CEQA Guidelines (14 Cal. Code Regs. Section 15000 et. seq.). The Final MND is available at City Hall, City Clerk Office or the Community Development Department, Planning Division, located at 125 E. College Street, Covina, CA, 91723, or at www.covinaca.gov.

The City solicits any information and/or data that any citizen wishes to provide concerning the proposed Amendment, and all interested citizens are invited to attend the public hearing.
