AN ORDINANCE OF THE CITY COUNCIL redrawing COUNCILMANIC DISTRICT MAPS, CONFIRMING SUCH REVISED COUNCILMANIC DISTRICT BOUNDARIES, AS REFLECTED ON THE ATTACHED MAP

THE CITY COUNCIL City of Glendora, California

WHEREAS, on September 26, 2017 the City Council of the City of Glendora ("City Council") held a final public hearing on establishing district boundaries, received additional public input, and formally selected the voting district map, set forth in Ordinance No. 2022 which adopted new district map of the Glendora City Council Election Districts to be utilized in subsequent City Council Elections; and

WHEREAS, the California Elections Code § 21601 requires that following each decennial federal census, and using that census as a basis, the council shall, by ordinance or resolution, adjust the boundaries of any or all of the council districts of the city so that the districts shall be as nearly equal in population as may be and shall comply with the applicable provisions of 42 U.S.C. § 1073, as amended. In establishing the boundaries of the districts the council may give consideration to the following factors: (a) topography, (b) geography, (c) cohesiveness, contiguity, integrity, and compactness of territory, and (d) community of interests of the districts; and

WHEREAS, on September 27, 2021 California Statewide Database provided Glendora with an official population estimate of 52,725 residents; and

WHEREAS, National Demographics Corporation (NDC), the City's retained demographer, found the City Council Member Residency Districts varied so that the districts no longer met the criteria specified in Election Code § 21601, and conducted public outreach throughout May and November 2021 regarding the redistricting of City Council Member Districts; and

WHEREAS, throughout the foregoing process, the City engaged in a significant amount of public outreach and engagement required by California Elections Code § 10010; and

WHEREAS, on November 9, 2021, pursuant to California Elections Code § 10010(a)(2), the City Council held a public hearing where the public was invited to provide input regarding the draft maps/proposals to adjust the boundaries of the City Council Member Districts and the City Council selected Draft Plan 103 - District R ID 69773 and Draft Plan 115 - District R ID 75108 for further consideration; and

WHEREAS, on November 30, 2021, pursuant to California Elections Code § 10010(a)(2), the City Council held a public hearing where the public was invited to provide input regarding the draft maps/proposals to adjust the boundaries of the City Council Member Districts and selected the proposal identified as Plan 103 - District R ID 69773, depicted by the map and corresponding demographic information attached to this Ordinance as Exhibit A and B, and compliant with Elections Code § 21601.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENDORA DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. The map attached hereto as Exhibit A, and incorporated herein, shall be and hereby is adopted and determined to constitute the five (5) Councilmanic districts in and for the City of Glendora; and

SECTION 2. City Council elections shall continue to be conducted "by districts" in five districts set for the in Exhibit A, as provided in Government Code § 34871(a), with a rotating mayor elected from among the members of the City Council, as provided in Government Code § 36801. The "term 'by district' . . . shall mean election of members of the legislative body by voters of the district alone," as provided in Government Code § 34871(d).

SECTION 3. Section 2.04.090 of the Glendora Municipal Code is hereby amended, to read in its entirety, as follows:

"2.04.090 Commencement of District Elections. Commencing with the general municipal election in November 2022 and thereafter, the voters in District 1 and 4 shall elect Members of the City Council by district for full four (4) year terms. At the general municipal election in 2024 and thereafter, the voters in Districts 2, 3 and 5 shall elect Members of the City Council by district for full four (4) year terms."

SECTION 4. While City Council Members will continue to be elected by the residents within the five district, individual City Council members will represent the entire city not district geography.

SECTION 5. The Mayor shall sign this Ordinance and the City Clerk shall attest and certify to the passage and adoption thereof and cause same to be published at least once in the San Gabriel Valley Examiner, a weekly newspaper of general circulation, published in the City of Glendora, which newspaper is hereby designated for that purpose (Government Code § 40806); and thereupon, and thirty (30) days after its passage, this ordinance shall take effect and be in force.

SECTION 6. City staff are hereby directed to provide a certified copy of this resolution and Exhibits A to the Los Angeles County Registrar of Voters for use in subsequent City of Glendora City Council Elections.

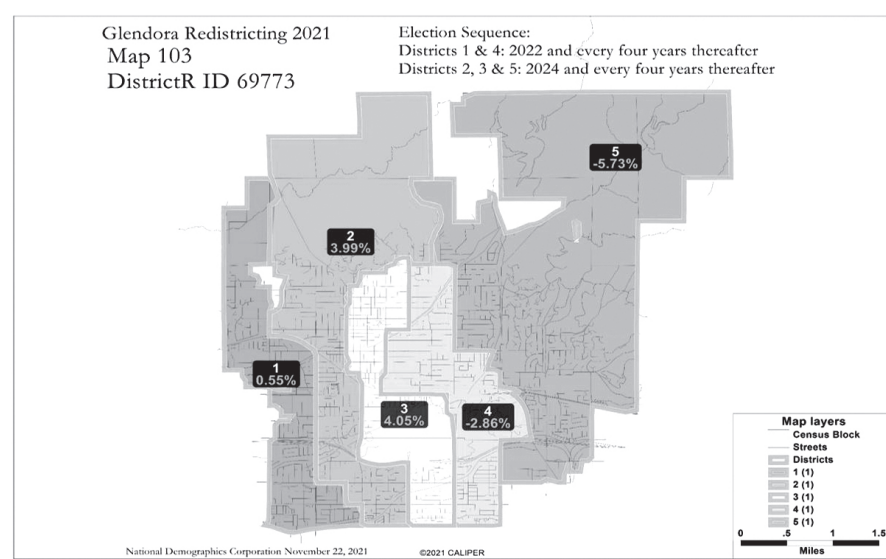

WHEREAS, the applicant, Jun Park (property owner representative) filed an application requesting approval of amendments to the Glendora General Plan Map; as well as the rezoning and establishment of site-specific development requirements pursuant to a Planned Redevelopment (PR) zone; and Development Plan Review to allow construction of a 20,974 square foot medical office building on certain property located at 210 S. Grand Avenue and 412 W. Carroll Avenue, Glendora, California (Project No. PLN17-0039); and

WHEREAS, pursuant to Glendora Municipal Code Section 21.06.020 A: The purpose of the planned redevelopment zone is to provide for development on a comprehensive basis by using site planning techniques not permitted through the literal application of zoning and subdivision regulations and to produce an environment of stable, desirable character in harmony with existing and potential development in the surrounding area. The planned redevelopment zone is intended to achieve the following:

- 1. To protect the public health, safety and welfare;
2. To implement the policies and programs of the general plan and applicable specific plans;
3. To preserve the environment and natural resources;
4. To attain the physical, social and economic advantages of comprehensively planned land uses;
5. To ensure aesthetic development;
6. To provide for adequate amenities, facilities, infrastructure and services;
7. To promote the efficient use of the land; and

WHEREAS, pursuant to Glendora Municipal Code 21.06.020 B and C, the development requirements and permitted uses are currently undetermined and shall be established by City Council. In addition, GMC Section 21.01.050(B)2 states: An amendment of the provisions of this title, including the official zoning map may be initiated by the director, commission or council; and,

WHEREAS, the environmental review for the project's General Plan Amendment, Zone Change, DPR, and Lot Line Adjustment was processed in accordance with the requirements of the California Environmental Quality Act (CEQA) and the Initial Study and Mitigated Negative Declaration (IS/MND) was available for public review from December 30, 2020 to January 28, 2021 (due to Covid-19, the notice was not posted by the County until January 6, 2021, so additional time was provided to accept any late comments); and

WHEREAS, a public hearing was held by the Planning Commission of the City of Glendora on March 2, 2021 and June 1, 2021, after due notice was given as required by law, at which time oral and documentary evidence was introduced along with the written analysis of the Planning Division of the City of Glendora, and the Planning Commission recommended approval of Project No. PLN17-0039 to the City Council; and

WHEREAS, the City Council held a public hearing on August 24, 2021 and October 26, 2021, after due notice was given as required by law, at which time oral and documentary evidence was introduced along with the recommendation of the Planning Commission of the City of Glendora. The City Council concluded with an approval of the project's land use and entitlement items on a 5-0 vote. This approval included the subject zone change.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENDORA, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. The above recitals are true and correct and are incorporated by reference.

SECTION 2. The City Council based on the evidence in the record inclusive of the staff report, and written/oral testimony, hereby approves a zone change designation as described as follows and shown on Exhibits A and B, which are presently zoned as Parcel A, Commercial (C-3) with a Height Overlay (H); Parcel B, C-3; and Parcel C, Medical Services (MS) and that they would be reclassified as Planned Redevelopment. The subject properties are addressed as 210 S. Grand Avenue and 412 W. Carroll Avenue, Glendora, California.

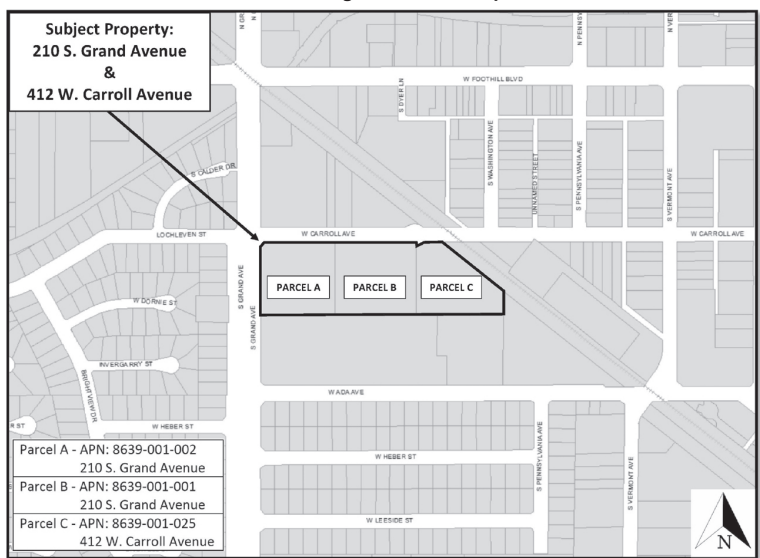
